# Beware of TORA\_V4

**TL;DR: TORA is not only a toxic and manipulative gossiper, but also a predator, a groomer, a zoophile, a transphobe, a liar, and an incestuous and pedophilic individual. They're not only generally problematic, but their extremely rude and disgusting actions have done irreparable damage to the community.**

TORA showed porn to minors, TORA groomed one of their fans, TORA's friends wants to cover them up and harass anyone who is against them, TORA did racist and transphobic remarks, TORA did illegal tactics; TORA is someone who for years has taken advantage of their fanbase and contacts so that they and their friend group can **still** engage in bigoted toxic patterns of behavior, and should not be allowed into public spaces of the fandom.

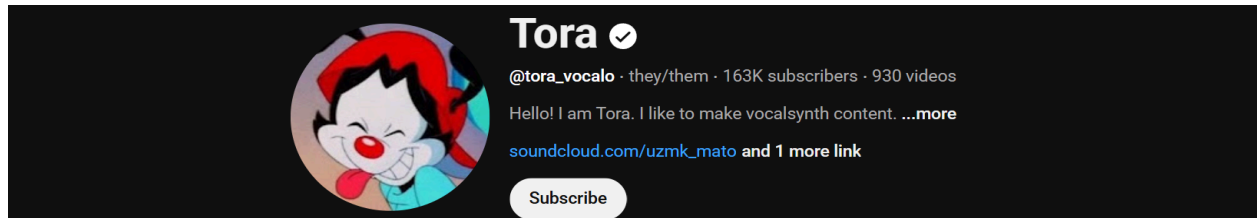

**So far, there have been more than 5 call-outs regarding TORA, all the information about them is now organized and reanalyzed in different tabs; Consider this document as a "Master" Document, as it also includes even more and new information.**

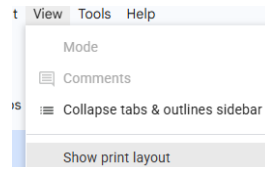
Hello, I am **GenoX** (GenoXLOID), the person who has taken the time to write this documentation, and one of the many victims affected by the individual and group discussed in this document. As I write this, it's worth mentioning that I'm currently a **19-year-old**, whereas most of the time period that will be shown—where I was present to see most events myself—*was a minor between 13 and 15 years old.*

I can't believe I'm writing a document over a person who's at a significantly older age than me (TORA is *currently* a **27-year-old**), considering I had been planning to compile and write everything from this document for years, which due to my health, my studies, and other projects, I had to put it off for quite some time (Although, it was worth doing so, as I have grown up to notice more of the red flags present in this situation). **Due to recent events**, I felt it was necessary to organize all this information before they get more attention and support to a point where they can't be stopped and continue unaccountable for their actions, which they continue to demonstrate to this day, *from 2018 through 2026 and beyond.*

Any new contributions of information regarding TORA's actions permitted for display in this documentation is welcome for addition.

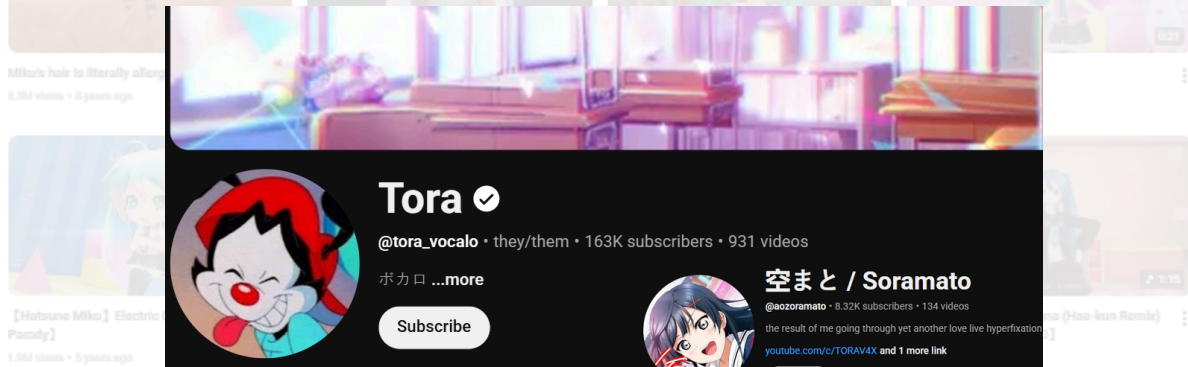

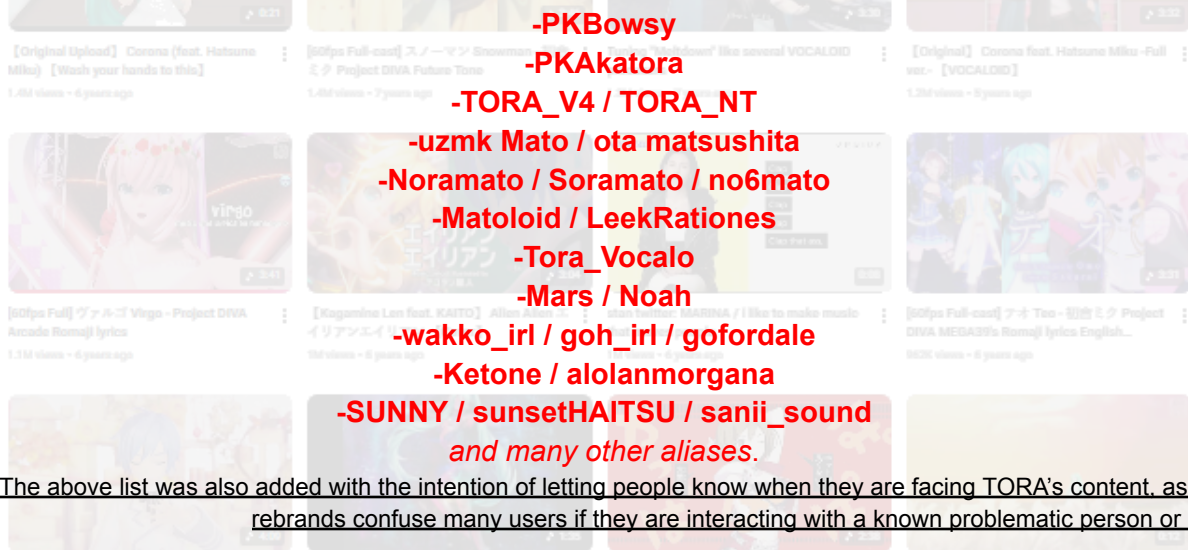
## Who's TORA?

**TORA** is a Vocal Synth user best known on **YouTube**; some of their most famous works include “Electric Chair”, “Miku’s hair is allergic to her arm”, “Corona ft. Miku”, “Miku goes flying”, and others. They also were present in the *Love Live* community as “**Soramato**”. Thanks to the attention TORA has garnered over the years, they have gained an own fanbase, and being able to connect with a *large* number of **other big artists** in the community.



It is important to note that *TORA has changed usernames over time*, whether for aesthetic reasons or for purposes beyond the visual (such as intentionally hiding their identity).

Some of the aliases we will use to refer to them in this document are:



The above list was also added with the intention of letting people know when they are facing TORA's content, as the rebrands confuse many users if they are interacting with a known problematic person or not.

Over the past years, Tora has been caught doing extremely questionable actions, **ever since 2018** (as far as documented) **up to recent years**. Although 3-5 years or more is generally considered a reasonable amount of time for someone to *change as a person and mature*, in **TORA's case, the opposite has been proven true**; they remained in constant contact with members of the community over this lapse of time, and once confronted with what they have done, TORA would taunt those who call them out, attempt to cover/hide and lie about the validity of the accusations, and swearing to take *accountability* for their actions, which in reality are still part of their character after so many years online.

# Grooming

## Grooming

**This tab mentions TORA sending pornography to minors, regardless of whether it was "Shota" or not. Please read carefully to understand the situation and avoid devaluing the children and victims who were exposed to and affected by this content from TORA.**

TORA's audience has *always* been mainly formed of underage users (from kids up to teens), regardless if the content TORA made really was actually targeted to young users of the community or not, **TORA themselves has acknowledged this fact** that their fanbase always had a large number of underage users in it.

these screenshots provided and the situation as a whole, it had no age restriction; only an opt-in nsfw role to access it. this is already an issue because tora's fanbase has always had a large amount of minors; this is something that tora has acknowledged, even in conversation with me personally. present in tora's server at the time was a user named [REDACTED], who was 15 at the

- Highlighted statement from the [2022 TORA call-out Google Document](#) -


In 2019, TORA's former Discord server has been letting the display of **NSFW** material in the server chats and voice calls (VCs) slide as if normal, when the server had many **underage users** being active in those channels (hence Tora being best known on *YouTube*, where they also let their followers know about the *Discord server invite*), whose **minors got exposed to multiple genres of NSFW content**.

As time went by, TORA's administration team would slowly increase to include users such as [720p](#), [REDACTED], [REDACTED], and many others. Starting from 2019, there were **only 2 users in charge** of moderating TORA's Discord server, those being *TORA* and [REDACTED].

The moderator [REDACTED] **enforced** the rule of prohibiting NSFW content to be posted at all, while TORA would **break** this rule *along with other members*.

During this time, **TORA was already an adult over 20 years old**.

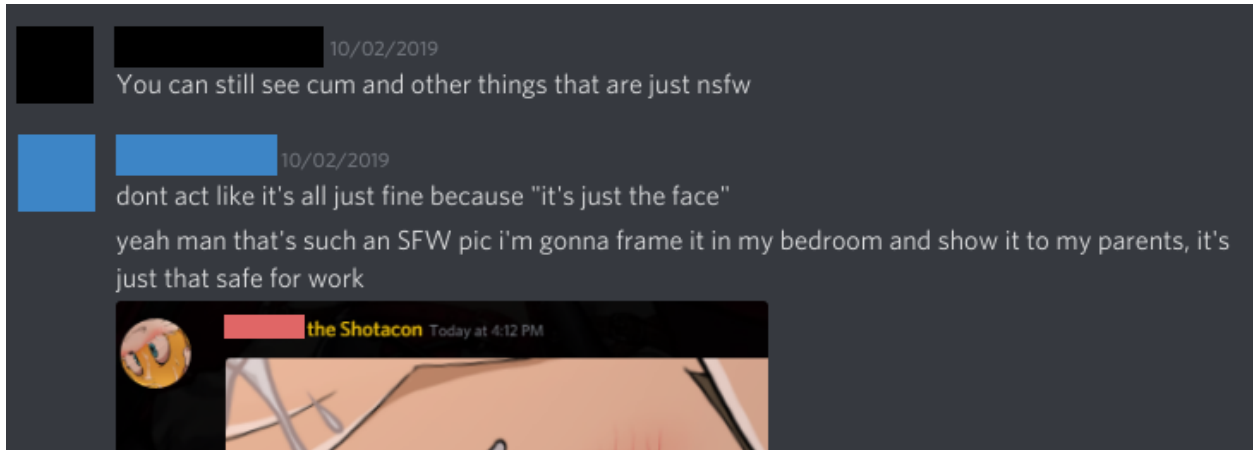

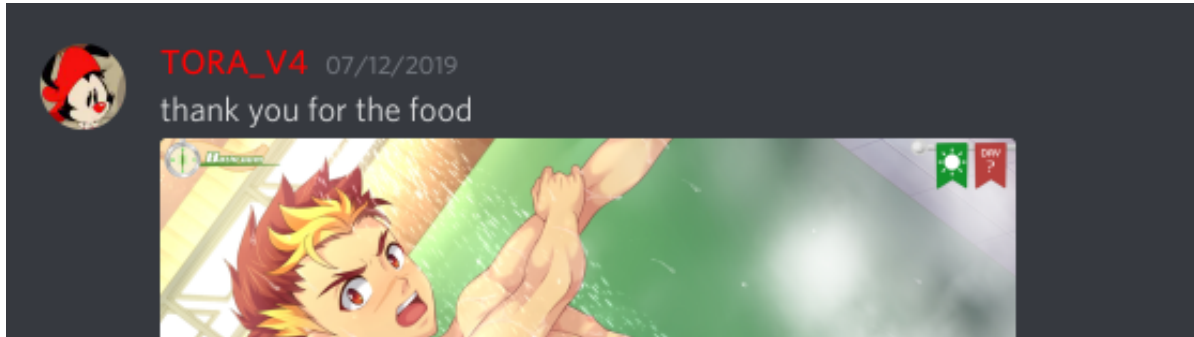

Furthermore, although TORA's Discord server was intended to be an "all-ages" space, it hosted **active and frequent discussions on NSFW topics unsuitable for minors, without any**

**proper security whatsoever to prevent the underage users from seeing/accessing those discussions or the NSFW content from it.**

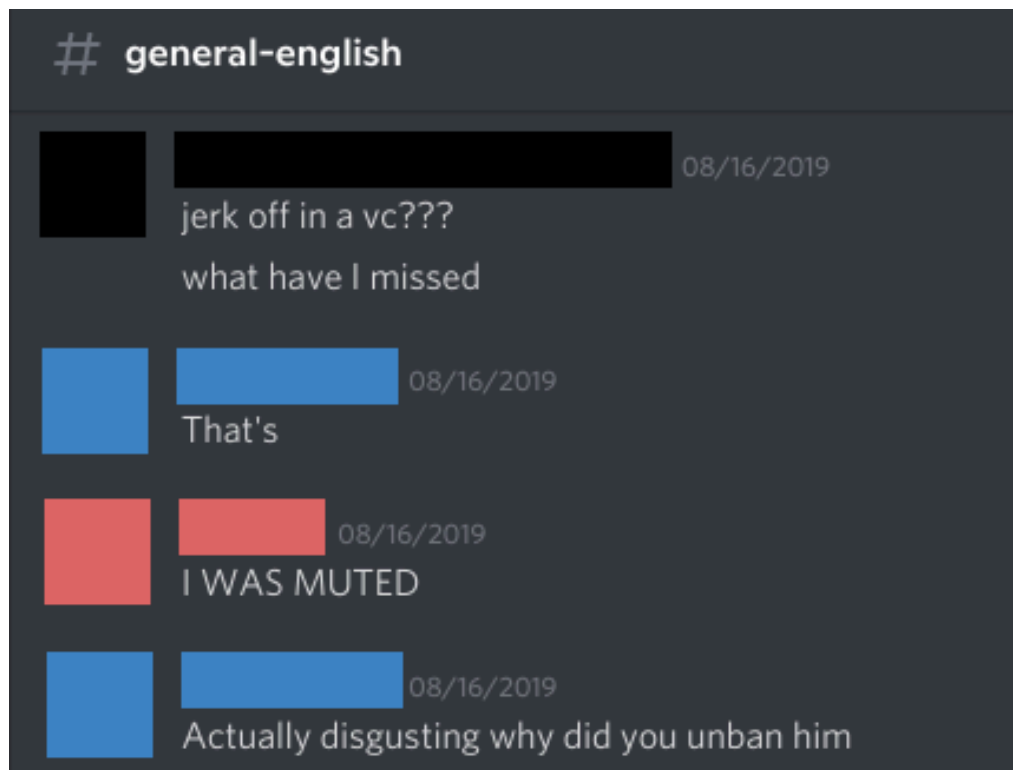
There were also multiple times where users (including TORA themselves) would post those NSFW images (*either cropped or blurred*) in the **general chats** for anyone to see, despite not being inside the NSFW channels category.

As mentioned previously, TORA would also be **streaming on voice calls** NSFW games gameplay (such as the R-18 game 'Camp Buddy') uncensored, most of those calls were done in **public VCs** where *anyone* could join and watch.

Sometimes, **TORA and other users would have their camera on in those calls.**

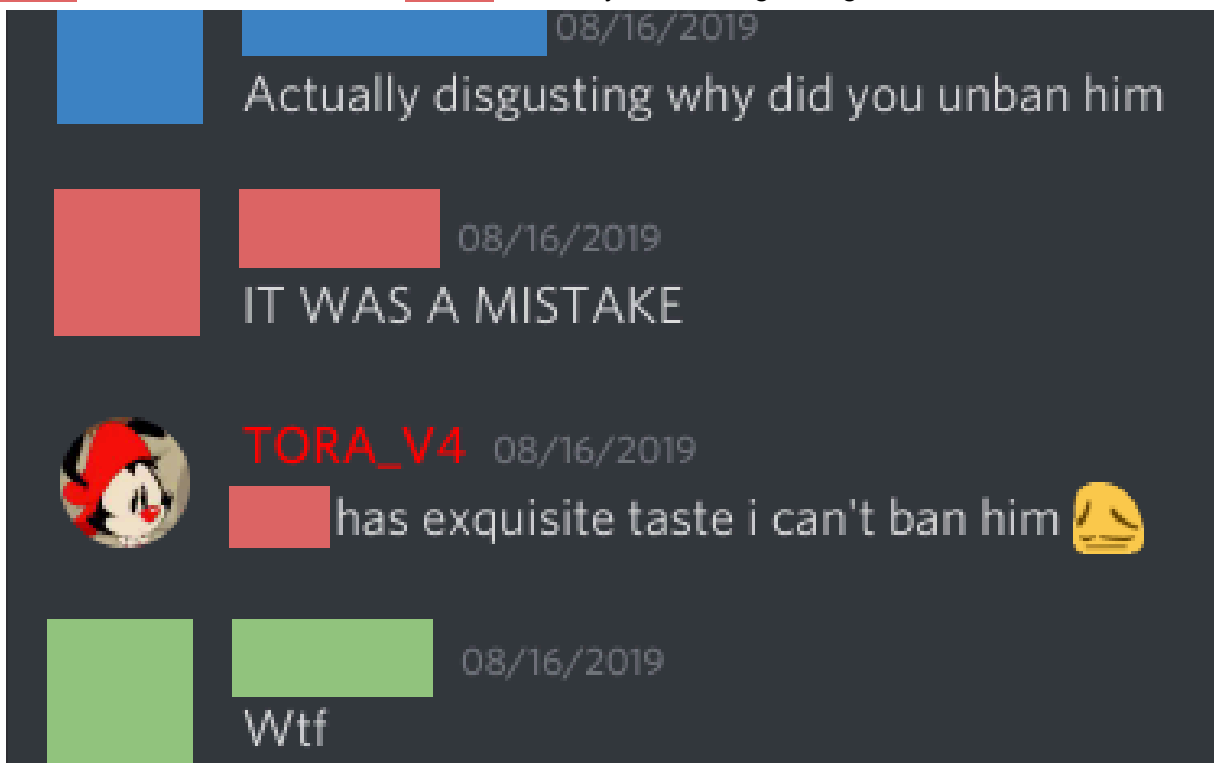


On one occasion Tora started streaming the NSFW hentai game camp buddy in his discord server, which mostly consists of 13-17 year olds. Some of the characters in the game look 12 years old, and I think that's why Tora plays it. Any of the underaged children in his server could have joined in that moment, but Tora didn't care. This behavior is deeply concerning on so many different levels.

- Above statement is from [redacted], an ex-moderator from TORA's server between 2020 and 2021 -

The user [redacted] (shown in the previous images) was a **15-year-old user** active within the server during those events. [redacted] was one of the main persons *sending NSFW content*, however, while the rest of members would tell them to **stop** doing so, **TORA encouraged [redacted] to continue** posting NSFW images (as it has been shown Tora and the 15yo were *close friends* during that time), calling it "*exquisite taste*".

As TORA was nowhere to be trusted with the decision of this matter, [green] (a **17-year-old** user) and many other users reported this to [blue], who ended up being the moderator banning [redacted]. **Until TORA unbanned [redacted]** as if they did nothing wrong.

## Inappropriate Sexual Conduct with Teens and Grooming

Discord has a zero-tolerance policy towards individuals who engage in sexual grooming, extortion (sometimes referred to as "sextortion"), or the sexual exploitation of minors. Users who engage in this behavior will be permanently removed from Discord on a first offense. We consider anyone under the age of 18 to be a minor and anyone 18 or over to be an adult.

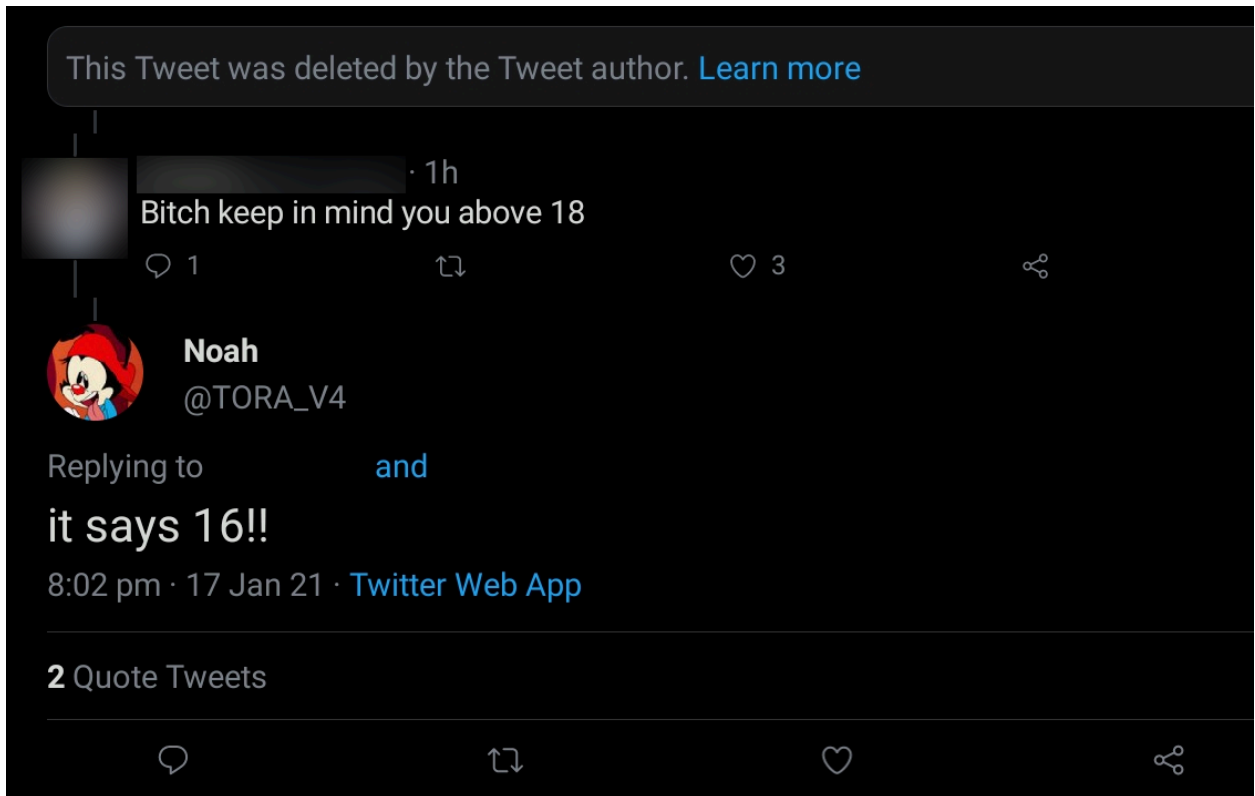



It's important to understand that TORA (who was *already* an **adult**) encouraging [redacted] (a **15-year-old**) to engage and post NSFW content is a form of **grooming and sexual exploitation**, regardless of whether the minor "consents" or feels they are doing it voluntarily. This behavior **attempts to normalize sexual themes** between them.

In 2021, in TORA's Twitter, they had a discussion with **underage users** from the community while using their **real country's age of sexual consent** (16 years old) as a way to defend themselves for being into one of the *fictional* characters from 'SK8 The Infinity', **Reki Kyan** (an anime character who is *portrayed as underage and canonically 16 years old*).





The character was not originally intended to be *sexually-appealing*. It must also be noted that, even if TORA's real country's age of sexual consent is **16**, at that age they are still seen as children, and only start being seen as adults once reaching the age of majority; 18 years old. An adult over 21 years old seeing a child in a sexual manner is extremely gross, and the age gap between them makes it worse.

What is the legal age in Netherlands? 

18 years

In the Netherlands, persons under the age of **18 years** are considered minors by law (Burgerlijk Wetboek/Civil Code). **From 18 years** people are considered adults. In Dutch youth policy, youth is generally defined as the age group **0-25 years**.

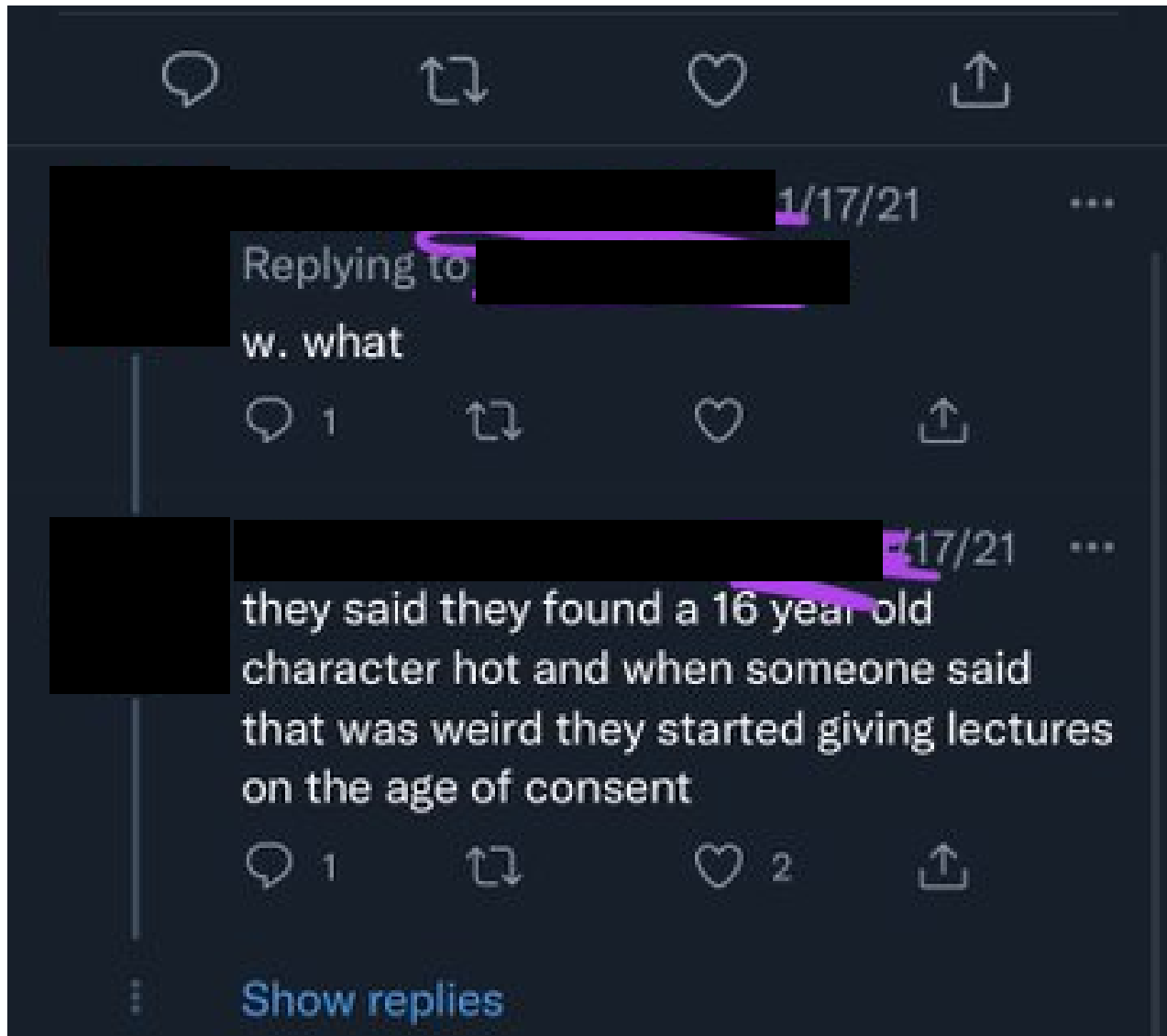

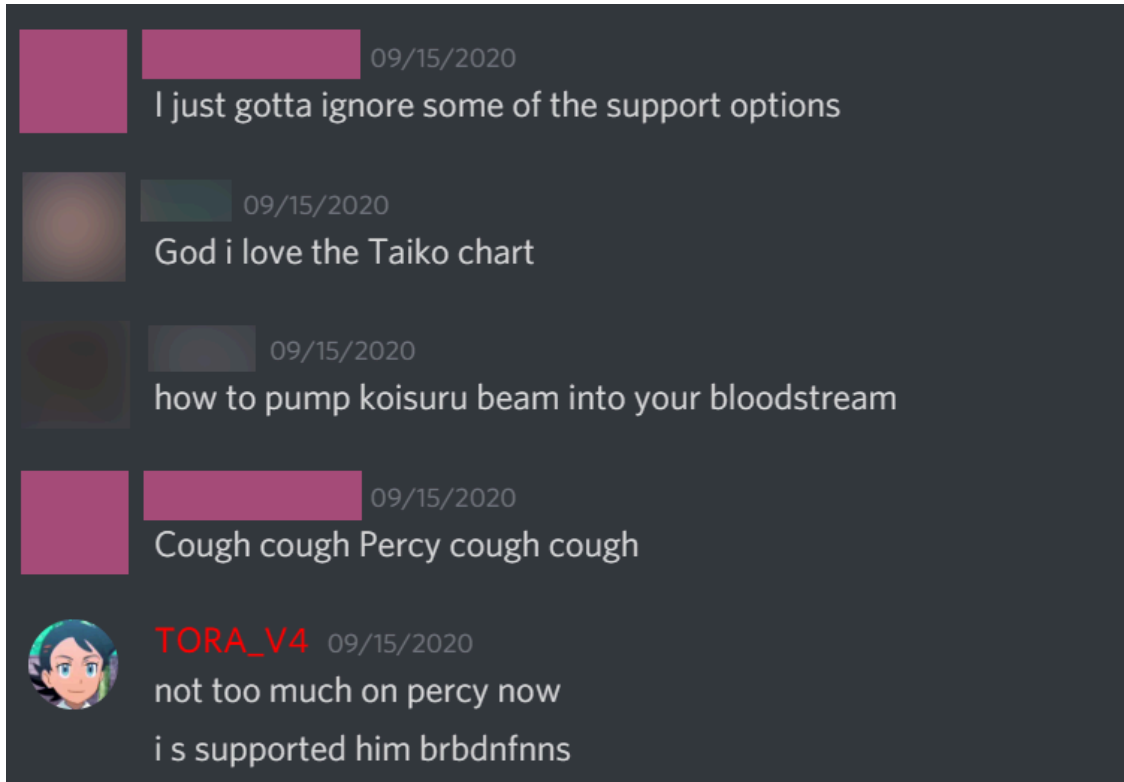

This would not be the only time TORA talked about *underage fictional characters* in such way **in front of real minors** online; for example, TORA would also be seen discussing such in their “all-ages” Discord server, this time TORA bringing up **Percy**, a child character from *Fire Emblem Fates*, allegedly because of TORA marrying them (as the game has an option to *marry underage characters*):

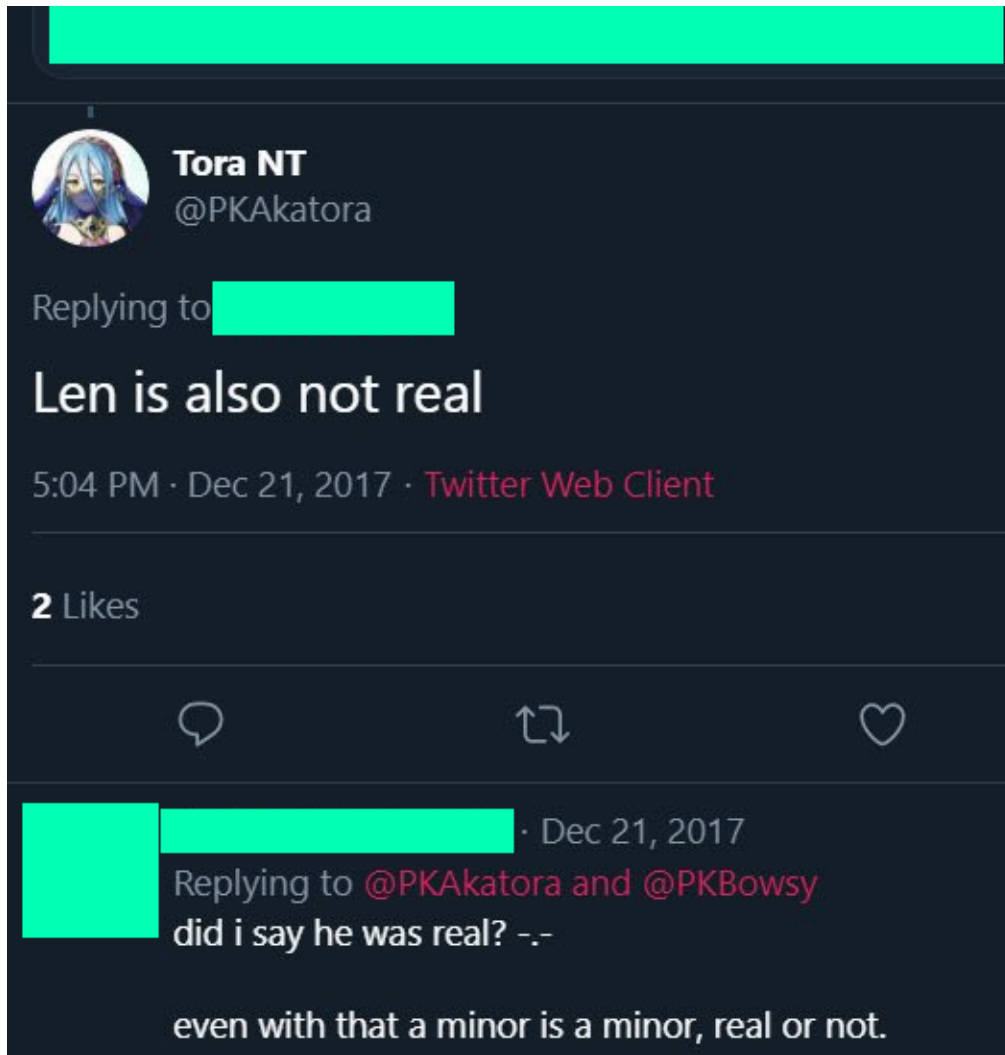

Tora (he, they pronouns)- Tora is a shotacon. When Hop got revealed for pokemon SW/SH he made a tweet (which has since been deleted) saying "thanks for the food Pokemon company". He frequently streams Shota Shota Burning Night by Giga-P in voice chats and talks about how he married Percy from Fire Emblem fates and defends it.

( [REDACTED] is me, notice how Tora gets upset when I call out fire emblem fates for having underaged marriage options)

Although TORA still insists they are not a **pedo** every time they get confronted about the accusations (such as remarking the old call-out posts last words from the writers), ***exposing children to any genre of NSFW material is still considered predatory and borderline pedophilic behavior.***

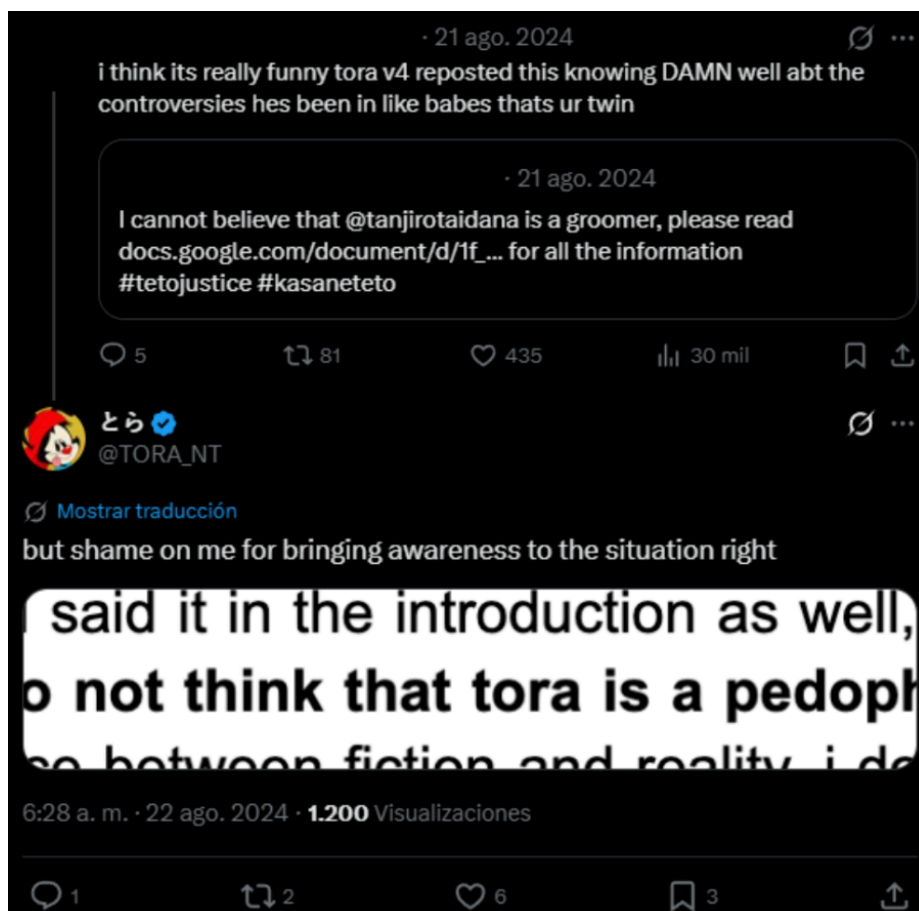

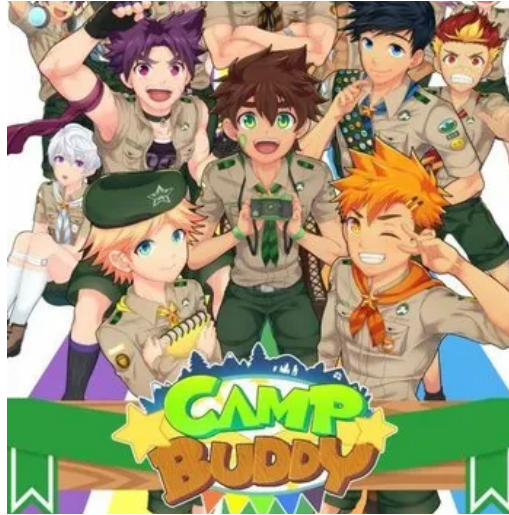

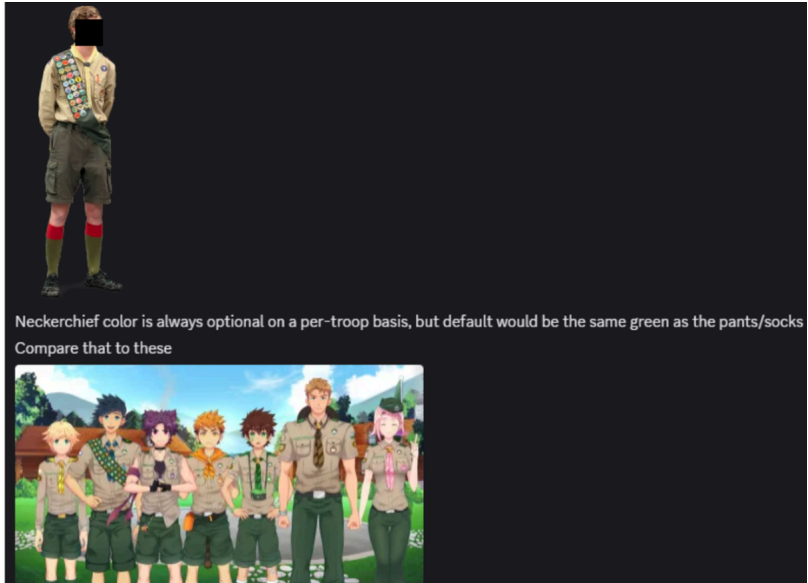
What's "Camp Buddy"?

**This section is added as TORA involved and exposed this 18+ game to real underage users online. TORA's actions go beyond just "pixel" characters.**

**Camp Buddy** is a **R-18** gay-themed (BL/Yaoi) dating simulator and visual novel. TORA's username is directly based on "**Taiga Akatora**", a **character from the cast of Camp Buddy (a 18+ game)**, something that makes Tora's whole brand inseparable from that game. TORA would expose real minors to the **NSFW imagery from this game** in the VOCALOID community, as seen previously in their "*all-ages*" Discord server.



***For full context;*** The game's creator "Mikkouno" labels his artwork as shota and shotacon, including designs of the **Camp Buddy characters**. **Shotacon** (sometimes shortened to *shota*) is a Japanese slang described as the counterpart of the "Loli" slang (*attraction to depictions of young girls*). For this case, it is an **attraction to depictions of young boys**, or an **individual with such an attraction**. *This also applies to characters who are over 18 but have the appearance of an underage.* *It would not be after some time that the developers would make the characters pass as "19-year-old adults", despite still being portrayed wearing uniforms of the Boy Scouts of America, specifically the teenage (max 18) branch.*



There's also **public instances** outside the Discord server where TORA would *use media related to this R-18 game* for their accounts, **even when TORA was well-aware most of their fanbase consisted largely of underage users**. One example being their old Twitter layout:

## Zoophilia & Manipulation

What is “Bestiality” content?

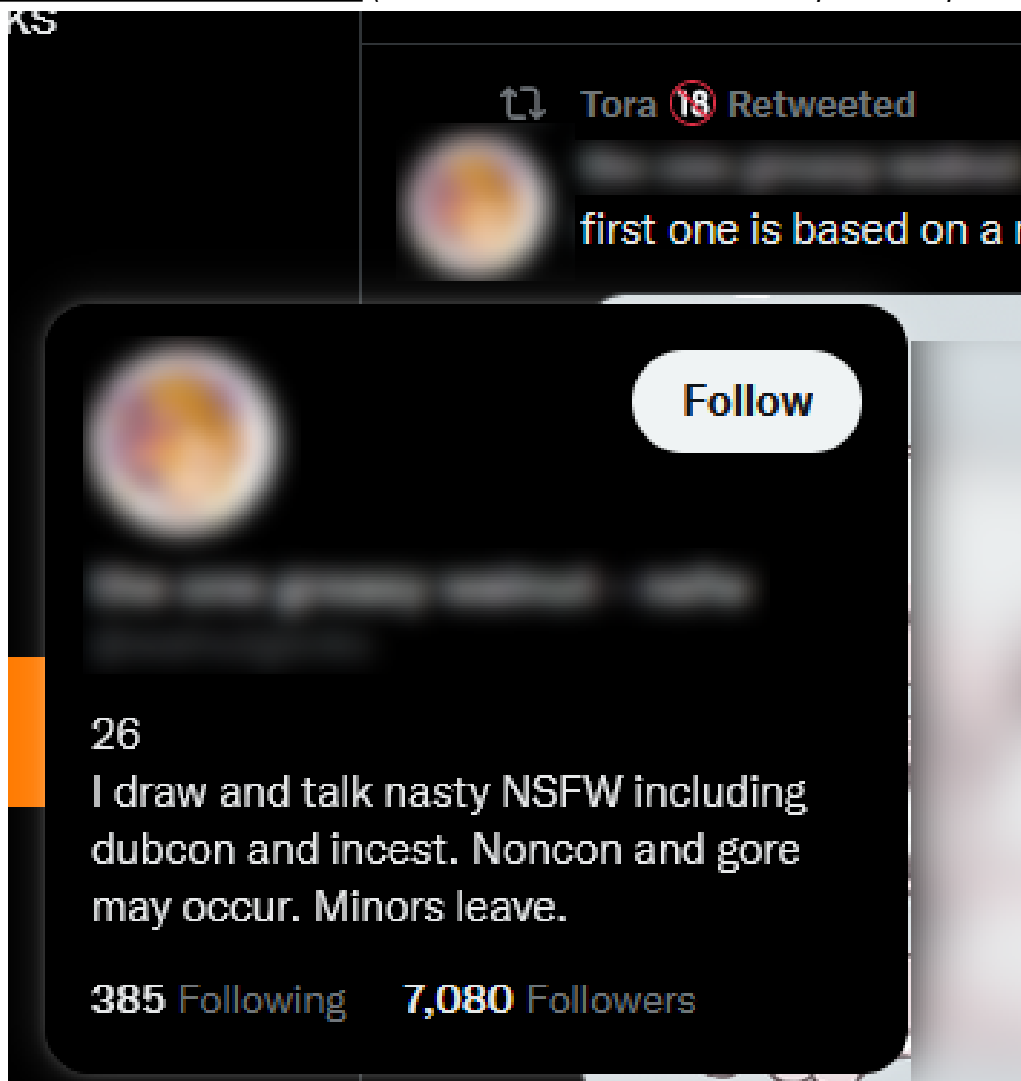
**Bestiality** (also known as *zoophilia*) refers to sexual activity between a humanoid being and a feral (non-human) animal.

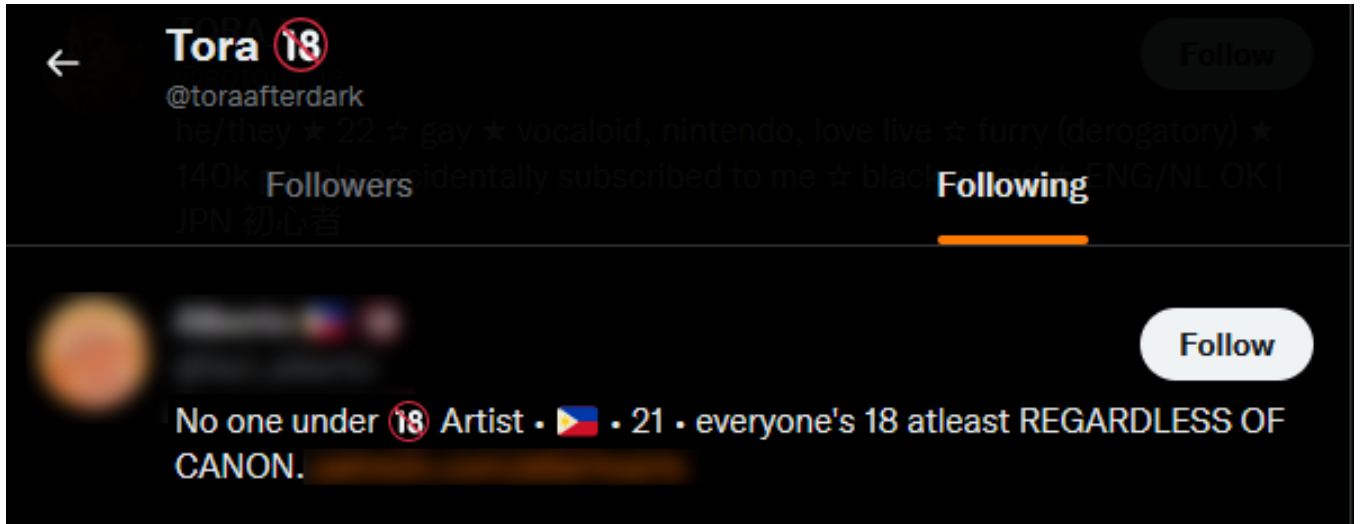
Bestiality content refers to media (such as images, videos, literature, artwork, etc.) **describing or depicting non-human animals in sexual activity to satisfy human beings’ desires.**

TORA’s NSFW Account

In 2022, TORA made a **public 18+ NSFW account** on Twitter. There, TORA **followed and reposted artworks from questionable artists.**

For example, one of the accounts TORA followed was **an artist who would draw Rape, Incest, Gore, and even Shotacon content (content which TORA has been exposed for previously):**

Another type of account TORA followed were **Pokephilia** artists; most of these **pokephilia** artists seen in **TORA's NSFW account** would directly draw **Bestiality** between the characters.



any way. furthermore, a majority of this person's art - feral and not - is human on animal. so do with that what you will. there is no nsfw content that i'm willing to post from this artist as none of it can be censored adequately, but here's a sfw drawing from them of two characters that they frequently draw in nsfw situations. take note of how one is... literally just an animal.

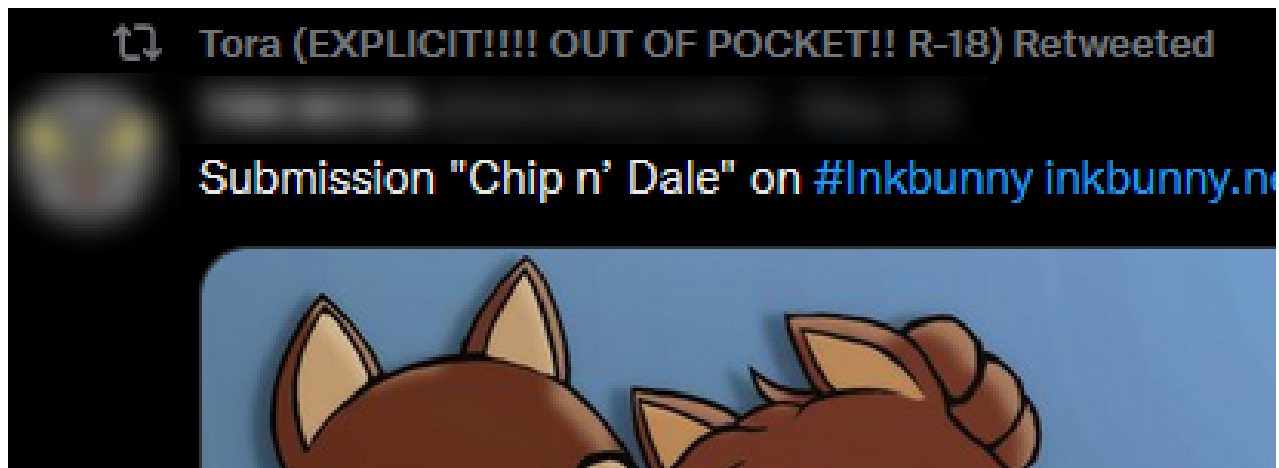
TORA tried to downplay the situation, tricking people into thinking this was “deduced” from the **Following** list of their NSFW account, and saying that these artists were followed by them without knowing the type of content they generally upload, *something that, given how clear the artists were with their content, is not a believable excuse from TORA.*

*“i do not thoroughly go through their accounts (which i should do), so i had no idea that this was even something i unknowingly subscribed to.”*

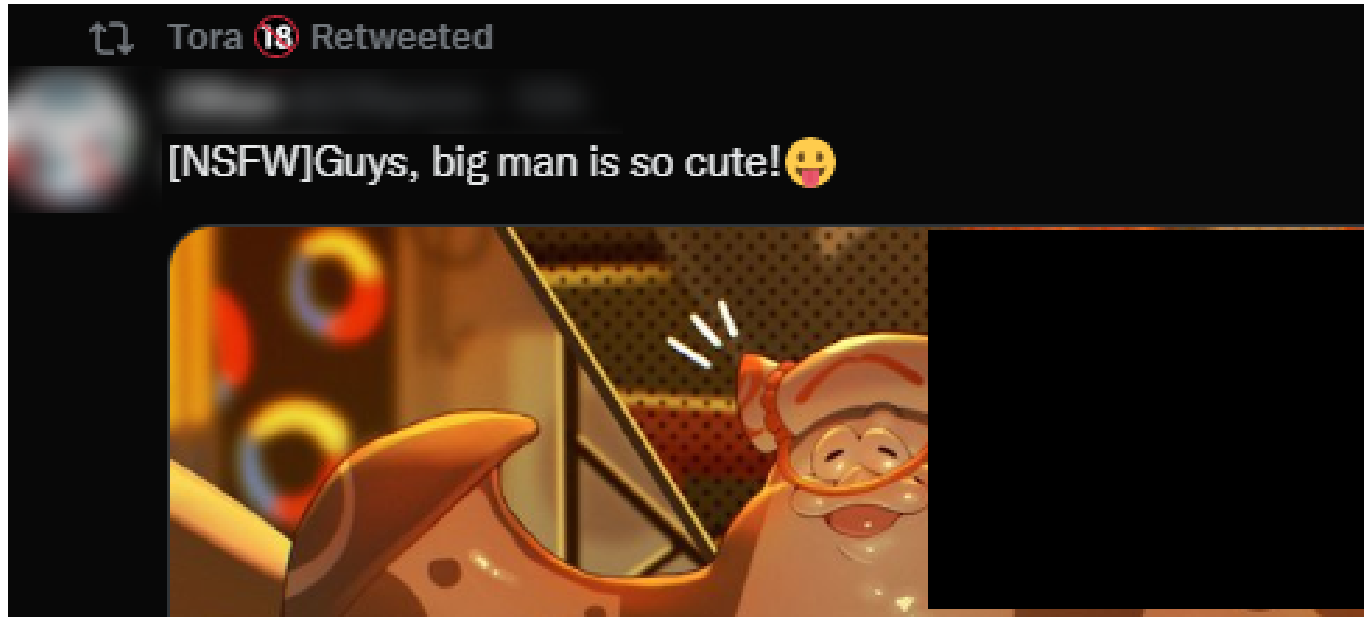
tora asserts that he made a mistake following people he followed for one art but multiple of these artists draw nothing *but* this problematic content. one account i included in the document, for example, draws almost entirely minor characters with an “all characters are 18” slapped on it. it’s ridiculous to pretend like he doesn’t know what the type of people he’s following are. if you are following someone’s account, you have to either hover over their icon or go to their profile for long enough to see that you’re following someone with rape/incest in their bio. be for real.

There would also be times TORA themselves would directly **repost** NSFW of characters that were **non-anthropomorphized**. One of the reposts featured *two small chipmunks*; those being **Chip & Dale**, Disney characters who would have, *although not all*, **multiple** instances of being portrayed as biologically-related, and could be seen as TORA reposting **incestuous sexual content**.



The other character was *straight up a manta ray*; **Big Man** from *Splatoon 3*. It must be noted that this artwork **directly kept the proportions and general appearance of the manta ray**.



**TORA's lies and denials about the existence of the call-outs**

In 2020, [REDACTED] spoke out in a YT post the TORA's Discord server situation (touching topics such as the NSFW content) and their personal experience while being inside the server before getting *banned* with the rest of users involved:

I was on PK's fandom a little while ago, I really liked his content and joined his discord. Everything ok at the moment, the people where really nice and all that.

Some time pass and some of the fans and I start to see small red flags here and there but nothing really important... Until a really fucked up incident on the NSFW channel... Some fucked up user started posting shota porn... We told the only mod on the server and, obviously, they banned that dude and everything seemed fine...

Until PK unbanned him...

We confronted him, including his mod, telling him that it was wrong and disgusting. He just started playing dumb saying thing to just let the incident go but we insisted, in the end he just said something like "it's not that big of a deal and i like it"... Bitch, it's like child porn... WTF?

Then he deleted the entire NSFW channel and banned us all :)

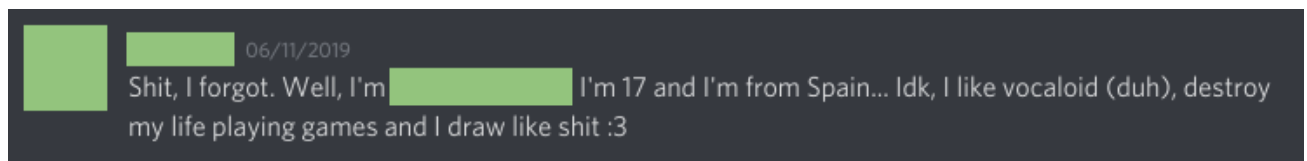

When the post above got brought up to Twitter, TORA attempted marking their Discord server's NSFW channels and whole situation as **"it didn't exist"**

After TORA's denials, things remained unclear. It would not be until **almost 2 years later** (January 2022), where [connection19 posted in Tumblr](#) evidence regarding TORA's Discord server and the shota NSFW content situation that was present in it, also attaching screenshots proving [redacted] was indeed another underage member present inside the server during the events.



In *September of the same year*, [another user wrote a Google document](#) mentioning the previous Tumblr post, while also attaching new evidence (such as the *NSFW account and zoophilic/SA content*).

There were moments when TORA would try to shift the focus away from the accusations and onto smaller details, whether by mocking the users, pointing out the wording of their messages, or by mentioning people who had nothing to do with the situation (mostly for comparison).

It should be considered that most users that were aware of TORA's behavior have **met them before Tora changed nouns to "they/them"**, as of why some screenshots might mispronoun TORA as "**he/him**". It's fair for victims and similar users to simply not be comfortable to check Tora's updated online profiles (most users would rather *avoid* Tora, after all).

In this thread, *despite it being about a fictional underage character*, TORA mentioned **one of their 2021 friends who did experience being a grooming victim**, as well as her attempting to make TORA understand why what they said was *harmful and insensitive*.

Additionally, TORA states they “*never remotely done or pursued anything with someone under 18*”, even when **TORA did groom** ██████ back then in their Discord server, as well as TORA talking in front of real underage users in a *sexual way* about fictional minors.

In 2022, *One day after* the publication of the [Google document](#) call-out, [TORA posted a Twitlonger](#) onto their account, titled “*addressing things.*”

Many users in the community have taken this apology as *extremely vague and rushed.*

**A lot of the accusations remained unaddressed** in this “apology” from TORA (such as the *incest, grooming, etc.*).

In this statement, TORA also acknowledged formerly being into shota imagery, along with accepting the existence of the NSFW content in their former “*all-ages*” Discord server; **the same media they have attempted *disguising as nonexistent* back then:**

## addressing things.

good morning, everyone. i'm not very good at these kind of things, nor am i good with words, but it would be irresponsible not to take accountability. i understand how it looks, but i ask of you to please hear me out.

i'll get right to the point... earlier today there was a google doc posted on my discord server, about my past and present behavior. there's screenshots of me defending and engaging with shotacon content, taken about three years ago. i do not engage with this content in ANY way shape or form anymore, and i will admit that i've done this in the past, but i want to say i've fully grown out of it and i've since realized how gross and wrong it was of me to do that. same thing for the situation with Reki from Sk8, i shouldn't have defended myself at all.

as for my behavior currently, i have been accused of still engaging with this type of content as well as b\*astiality art, which i want to say right now is not true at all. this was deduced from my following list on my NSFW account. however, i randomly follow artists when i see a picture i like. i do not thoroughly go through their accounts (which i should do), so i had no idea that this was even something i unknowingly subscribed to. not ONCE have i ever liked or retweeted art depicting minors or feral animals on my NSFW account, and that's something i'm very sure of.

i will not ask anyone to forgive me for this or even believe me, i understand if you don't, but i am 100% telling my truth and owning up to my mistakes.

Strangely, shortly before and after TORA posted the Twitlonger link in a post from their Twitter account, they started **bulk-RT'ing** (reposts) other tweets that were *unrelated* to the situation (such as artworks, mascot videos, etc.) onto their account, as a way to *cover up* the initial tweet that contained the Twitlonger.

tora made a tweet to his twitter circle (not publicly) at 12:27 EST am stating that he "can explain and will." he then went on to use twitter as he normally does and retweeted random posts until finally posting his apology(?) at 4:09 am EST. i'll address some parts of it now, but you can read it in full [here](#). excerpts from tora's twitlonger will be in blue.

3 days after being posted, **TORA deleted this Twitlonger 'apology'**, leaving in question if they really were going to take accountability for their actions.

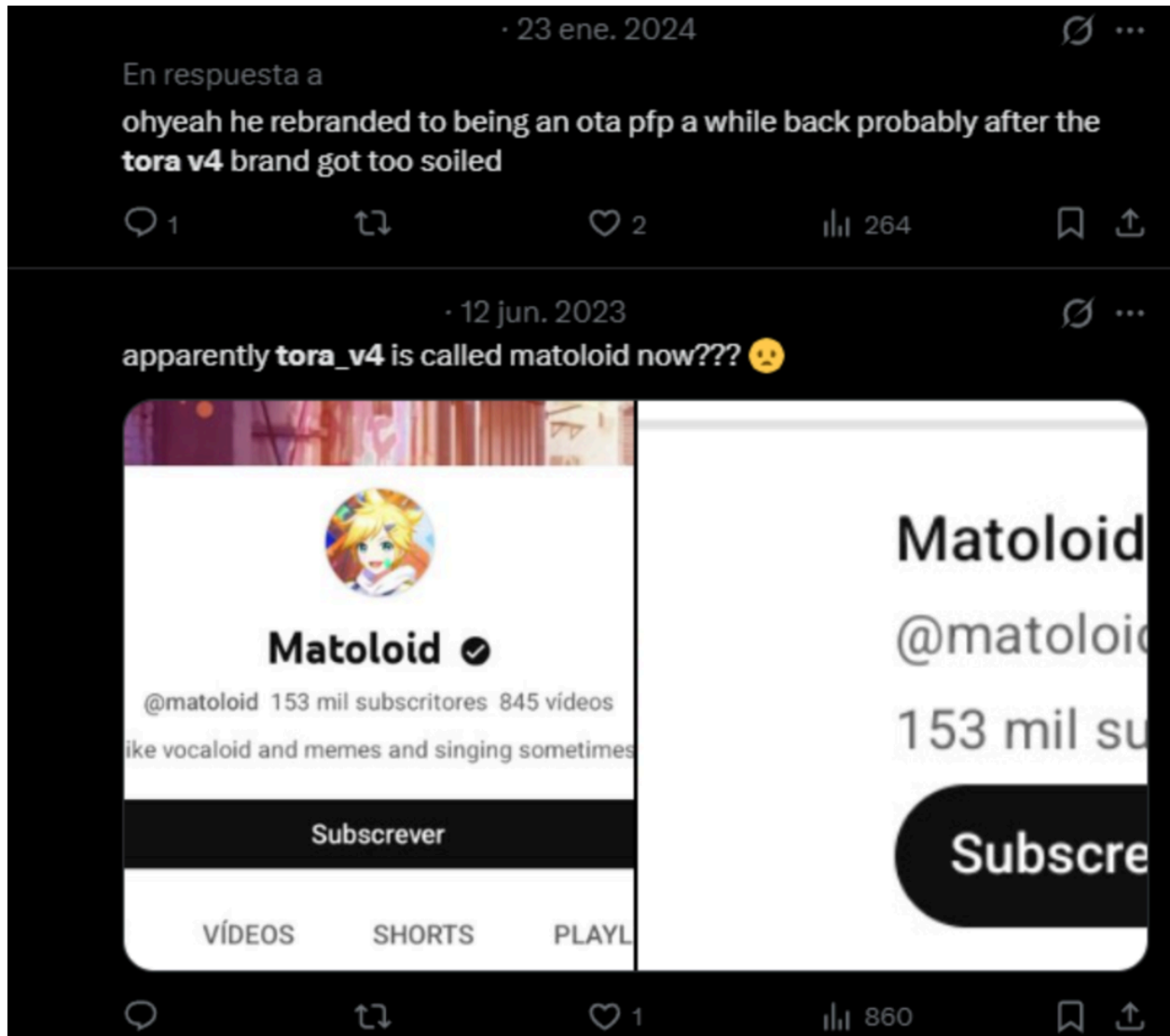
### **Username Changes and Rebrandings**

On the exact same day they erased the 'apology' to the accusations, **TORA changed the username of all their accounts** (YouTube, Twitter, TikTok, etc.) into 'Noramoto'.

This was clearly depicted as them covering up with a different identity until things cooled down after the exposure. In 2023, their username was then changed into "Matoloid". *There were more name changes during this period of time.*

**final final final update september 9th:** tora has deleted his apology and changed his @. i'm not going to update this further since 1. people most likely aren't looking at it anymore and 2. it's going to be the same thing for the foreseeable future (tora changes @ if it gets too bad, sweeps it under the rug). he has made it very clear now that he is shamelessly suppressing this information. he does not believe he's in the wrong and he does not want to change. thanks again for your support throughout this :) byebye

In 2023 (near August), a few of the users who were in TORA's circle noticed an account named "**Ketone**" going around; This account would also be seen in internal groups *between TORA's friends and ex-friends of them*, and there we also occasions where they would **hear Ketone in calls clearly being TORA's voice**.

They would later get the affirmation (by the people who *still* were friends with Tora) that **Ketone was indeed TORA making a new account with another identity**, something that would be different from previous times where Tora just rebranded their existing accounts.

For those ex-friends who had already distanced themselves from TORA and found out about this, TORA's current friends asked them to keep it a secret and not tell anyone. **This would force the ex-friends to get involved *once again* in TORA's risky and questionable tactics.**

In 2024, around January 22th, [Noramato](#) made a post in their YT channel community tab, announcing they were **supposedly leaving** and uploading a last cover near February of the same year as a "Thank You" for the people who followed them:

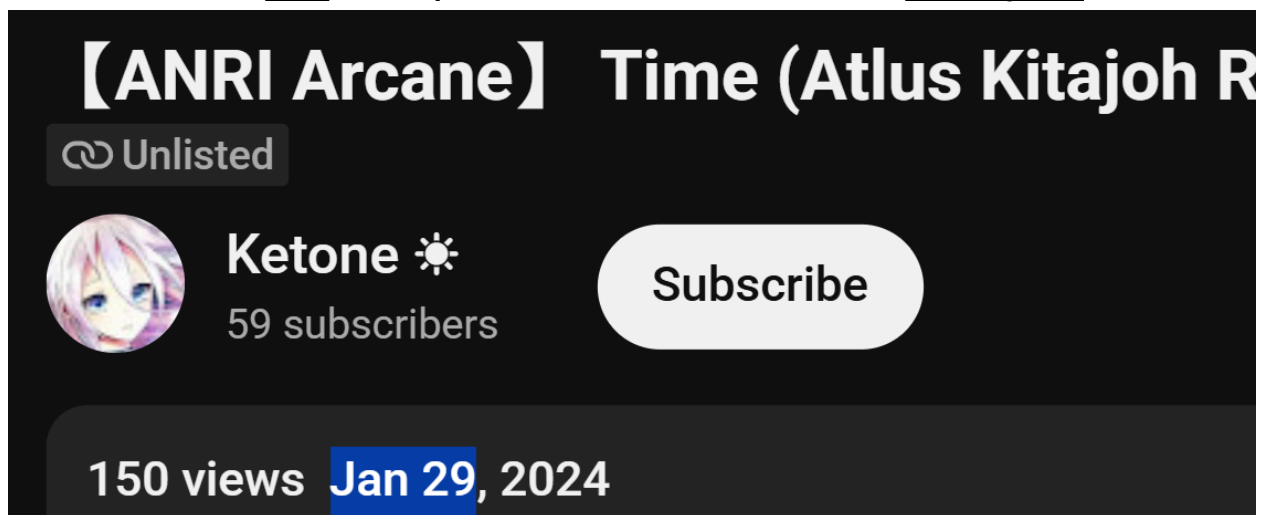

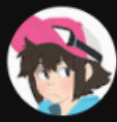
Considering the creation of the previously mentioned “Ketone” accounts, **it’s highly possible TORA was already prepared to move on from identities, abandoning their main accounts in order to be more active online as Ketone instead.**

This would also contradict their previous statements of “*prioritizing their mental health*” and “*staying in the VocalSynth community had a negative effect on them*”, **as most of posts from Ketone were done after the YT post, and would still be related to vocal synths.**

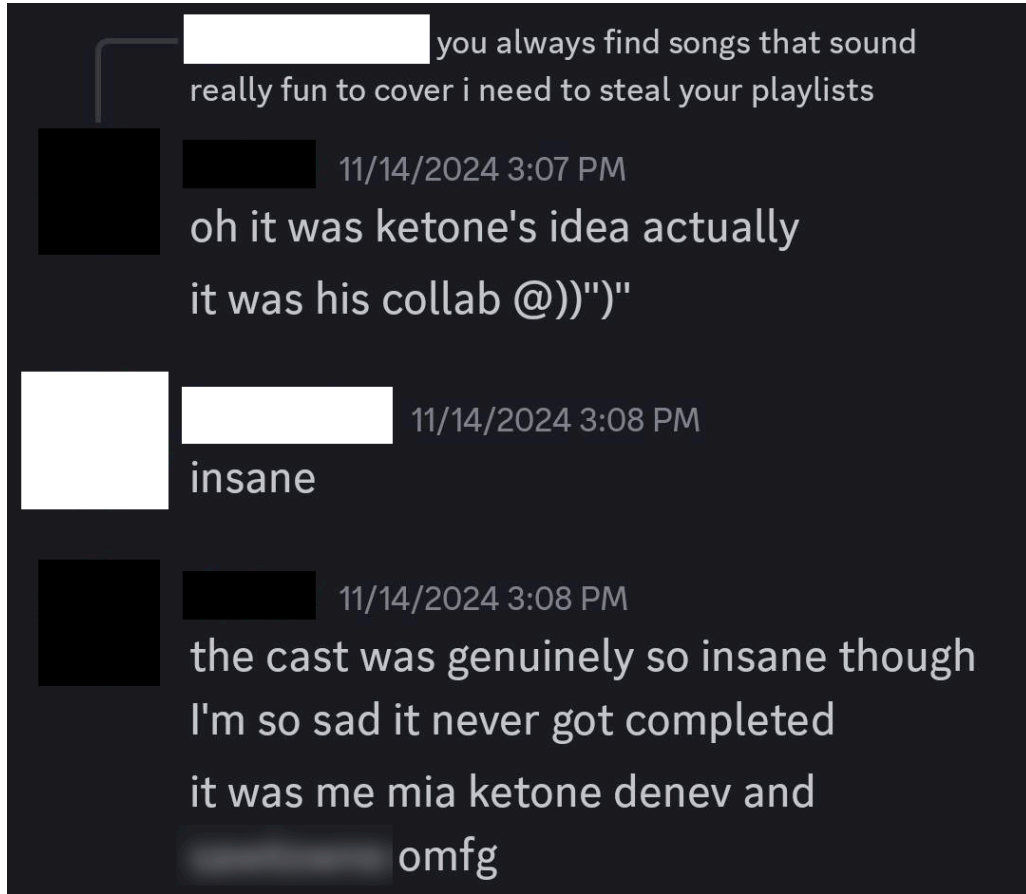

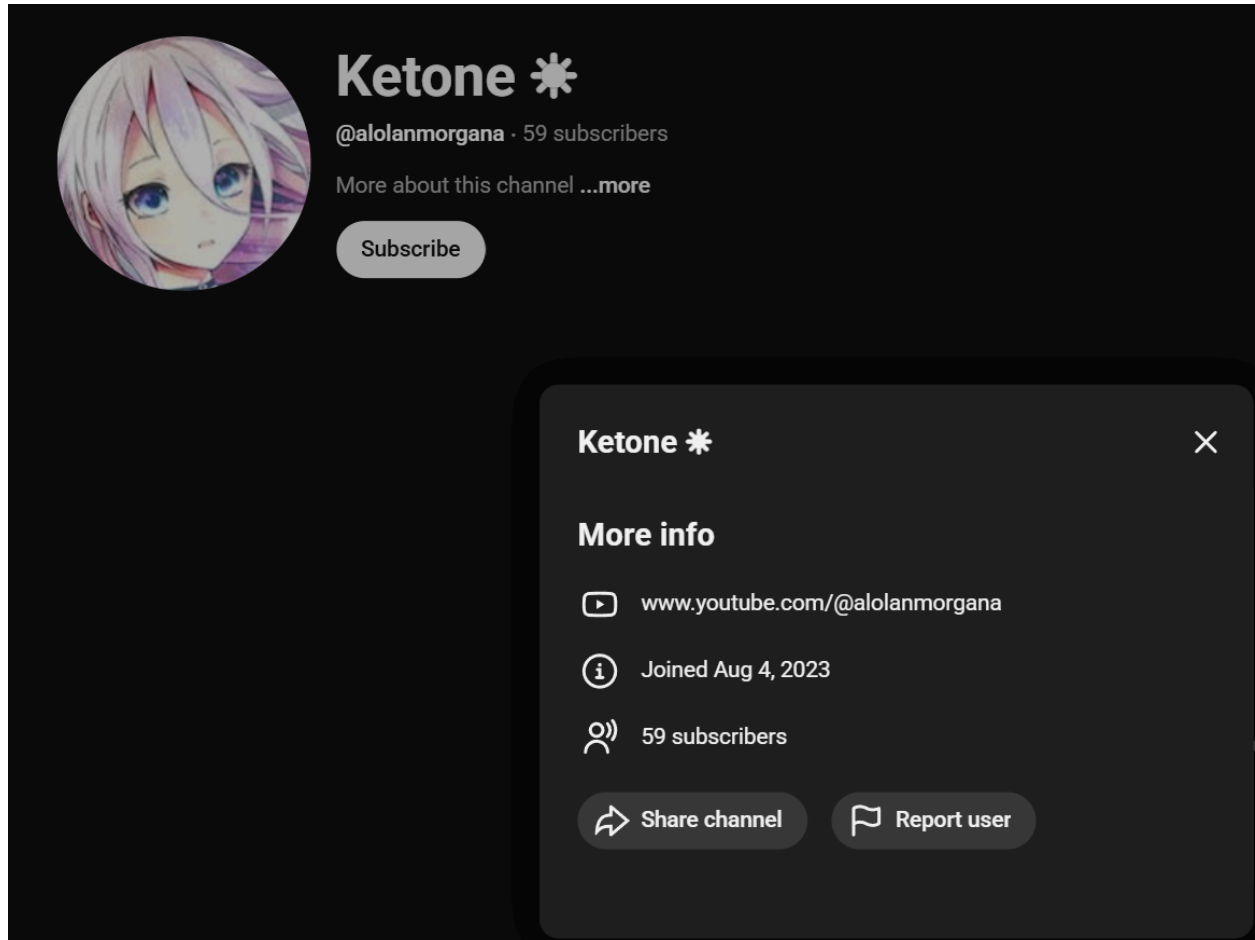

In early-2025, outside people who weren't in those internal groups noticed **Ketone's Discord account** was an old account from TORA made years ago and being reused for this new identity (as there were old chat logs from the Ketone account in other servers).

This would lead TORA to unlist everything on their [alt account YouTube channel](#), and abandon their **Ketone** identity just to go back to **purely using their old main social media accounts (Noramato / Matoloid)**.



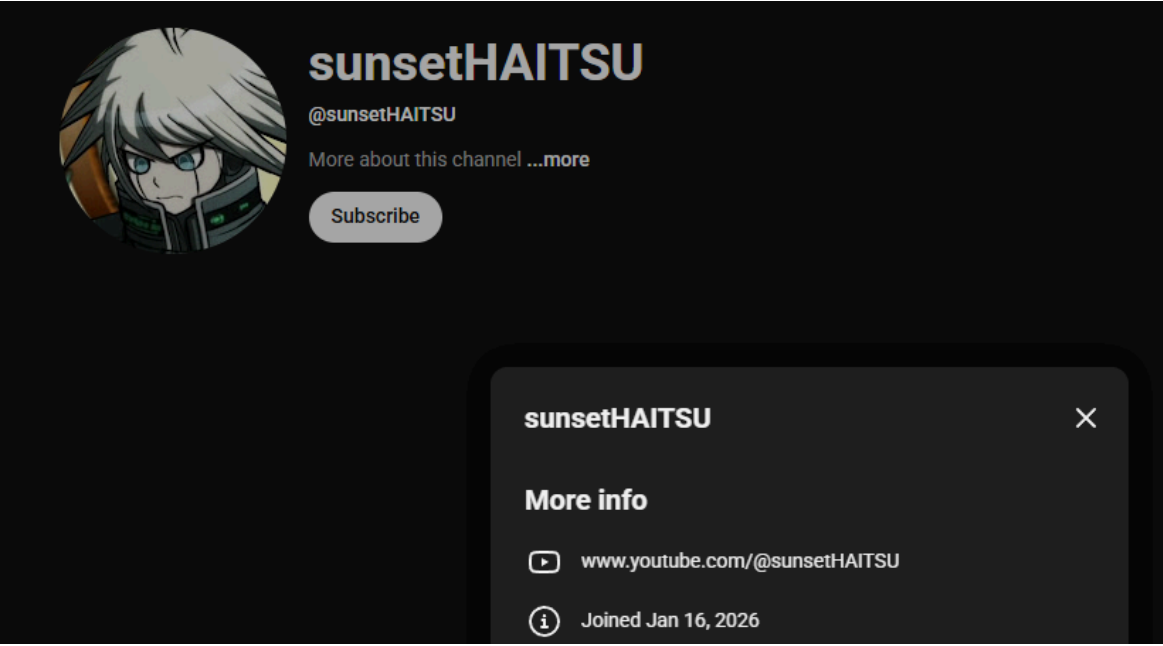

Mia (MSyphn)- Mia is a white Irish woman who makes racist jokes about black people and compared being friends with Tora V4 to being a victim of the holocaust in front of me, a jewish person. After she did this I forgave her, and her behaviors only became worse. For weeks following her "apology" she would talk over me in voice chats and try to do everything she could to prevent me getting a word in. She also started to invalidate all my opinions and said that if I like Persona 5 then I should feel bad because it promotes sexual assault.

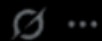

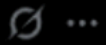



Strangely, in *April 2023* (just *1 year after* these last tweets), **she was once again getting involved in content from TORA**. In the [“Song of the Eared Robot” arrangement by TORA](#) YT upload, *most of the work* done for the video (illustrations, MV, Tuning and Mixing) was credited to the user “**ボボたぬき (Bobo Tanuki)**”. This user has turned out to be **Syphn under an alias**. This would also make **Syphn/Mia** one of the first people who, *after* distancing themselves from TORA, **became friends with them again** long before anyone else did.

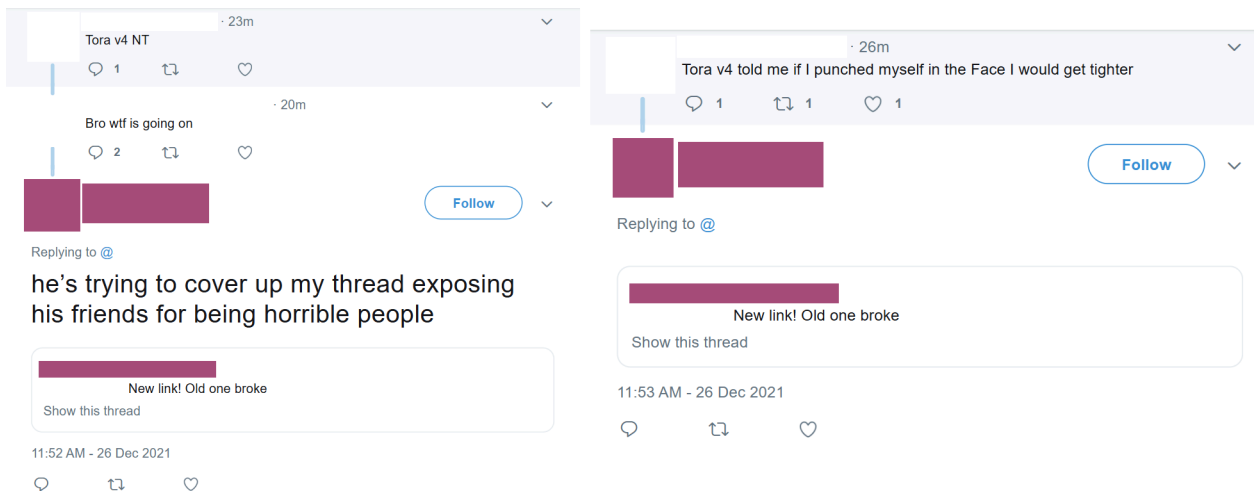
They are a very sick and manipulative person who desperately want to put themselves on a moral high ground despite being a pedo. He loves to call out other potential pedos to make himself look innocent, which is why he tried to cancel Vocaphilia recently. Not only is Tora a gross shotacon, he also loves to bully people! When we were in calls together he frequently called me fat, which was really upsetting because he knew that I have a history of struggling with body dysphoria. I've gone from 280 pounds --> 163 pounds and I still feel like a big guy because of my extra skin, and even after explaining this Tora continued to call me fat. A few weeks after I left his group I sent him a polite message in an attempt to receive an apology, but Tora decided to deflect the issue and say "everyone called each other fat" which is fucking bullshit. Tora called me fat at least 200 times in our friendship because he knew it caused me distress. His favorite moments to fat shame me were when we were playing a game against each other. When [redacted] attempted calling them out in 2021, TORA and friends would flood Twitter's search engine with their names as a way to make [redacted]'s call-out more difficult to find, as well as mocking [redacted] by saying "their call-out was not going to get any attention at all."

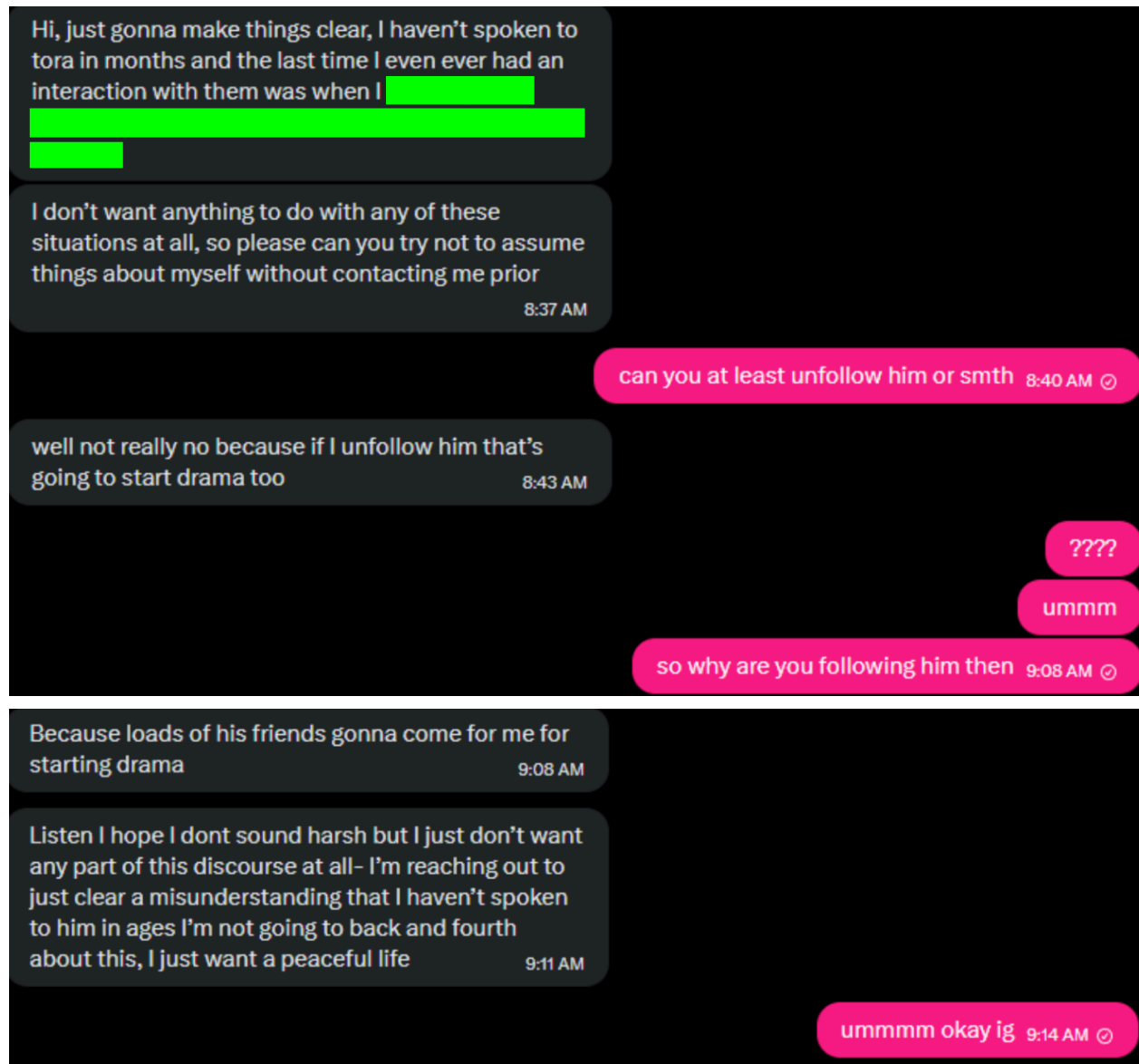

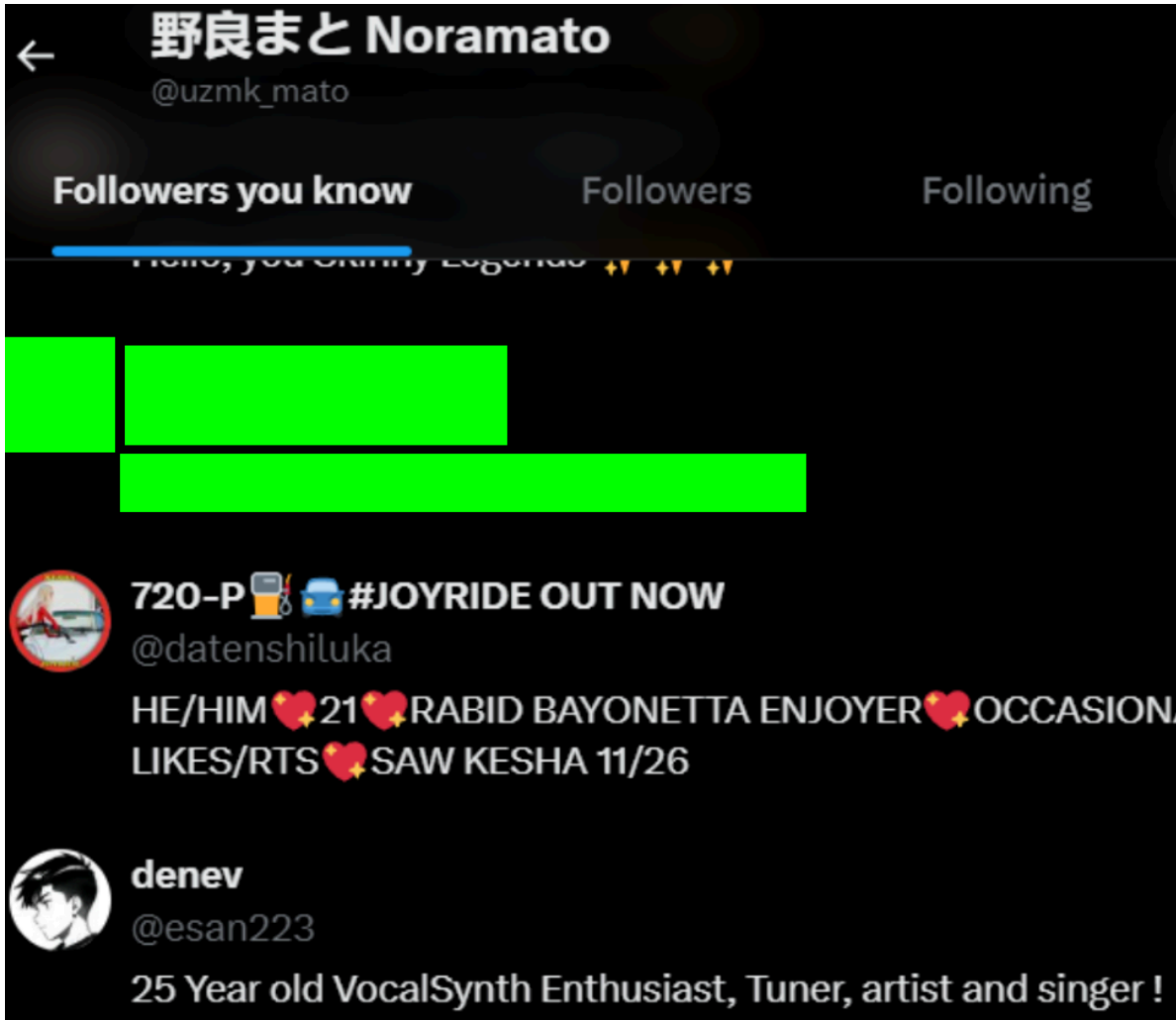

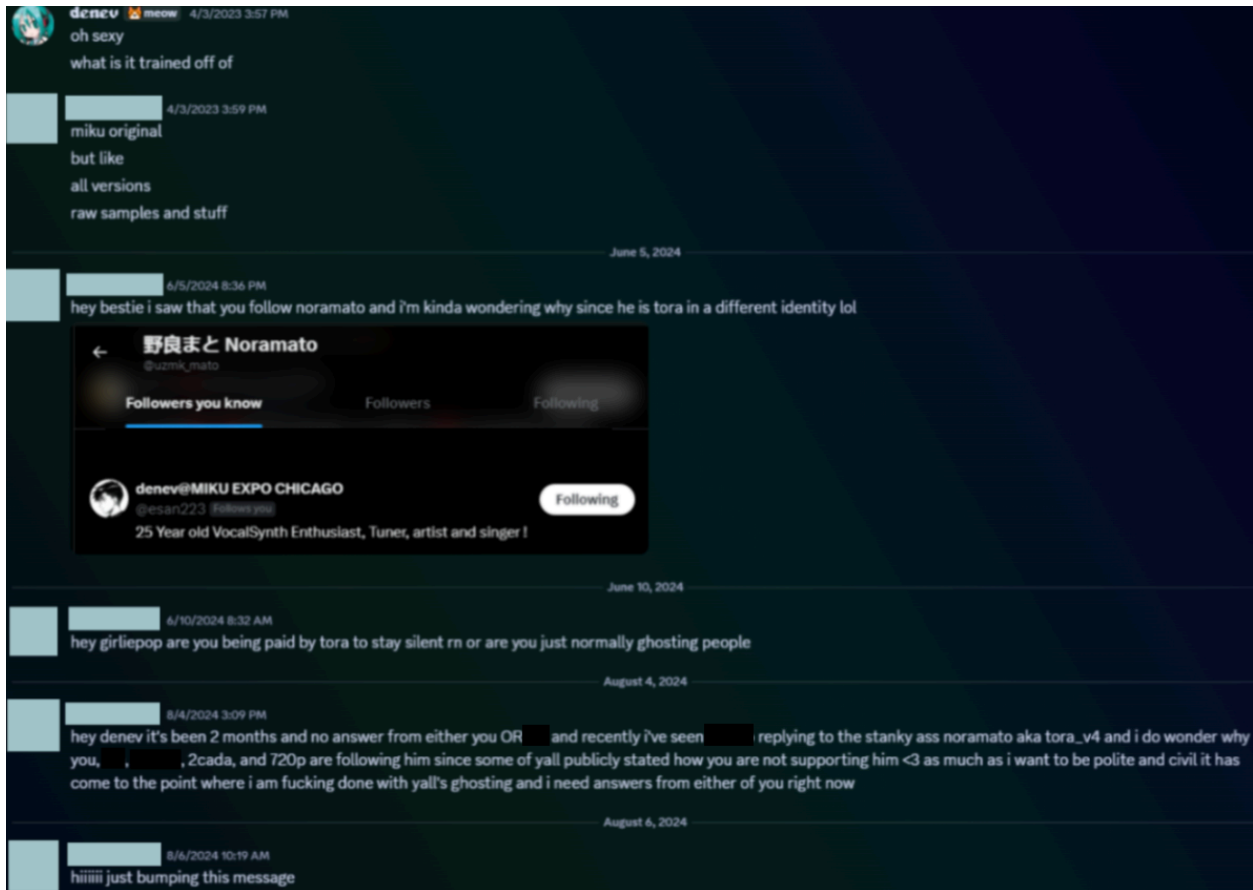

It was something that I asked peers about and said hey is this Tora, I was told yes and from the beginning of being told this I knew this was going to end terribly. While I never really spoke to him myself, people I considered my peers (720 mainly) was still friends with him through the entire ordeal, and during this time, there was a strange mentality that, if you were against Tora you were almost like... part of the woke mob ygm? like people would sorta act like you're crazy for not wanting to associate with him, because of this I just kept my silence and didn't interact because in retrospect people are gonna start realising it was them. This ended up happening. People who weren't familiar with Tora found out and his new lil persona just got abandoned, and that was the last time I heard anything about him. He was someone named ketone.. it was truly something I didn't understand people didn't catch onto sooner considering the tuning style and hyperfixations.

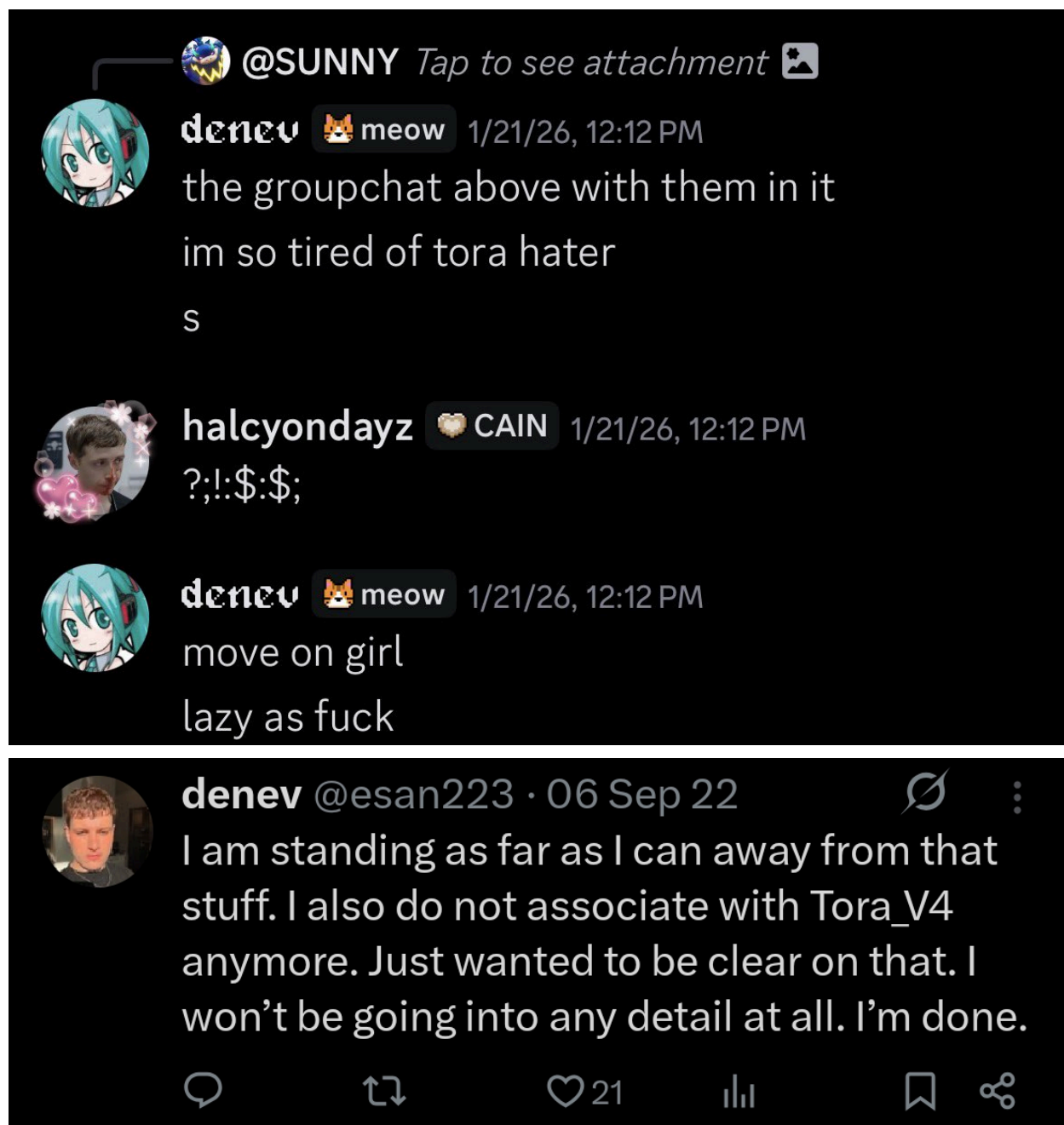

And just recently, in *February 2026*, along with the user **Prismatic**, they were exposed for [sending NSFW imagery to a 13-year-old & 14-year-old](#) in a Discord group chat for over 3 years, when both **720p and Prismatic were already over 18**.

In 2023, 720 (then 21) was added to the gc and he then began actively sending porn as well.

Although Prismatic was most likely not directly linked with TORA, **he was very close friends with 720p**, someone who has *proven to have been in constant contact with TORA*.

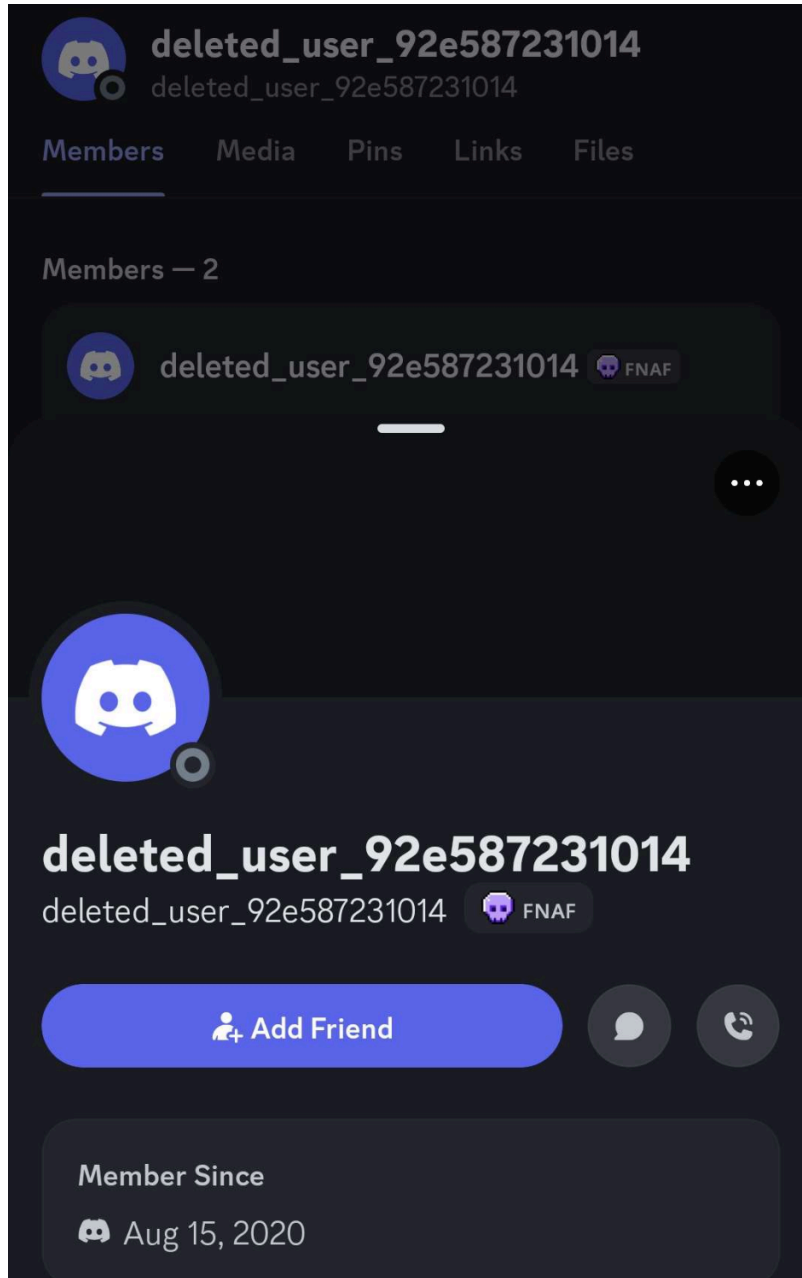
Just 1 day before the [call-out document about 720p and prismatic](#) was published, I received a DM from Prismatic; They told me the TORA call-out document from *September 2022* information was supposedly all “*bullshit*”.

*As someone who was also a victim present during the time TORA has done all the actions that were indeed mentioned in that document, I was extremely awkward with this attempt of trying to make me think all of what just happened was suddenly false information.*

**It would later be confirmed by one of TORA's ex-friends that TORA's current friends (such as 720p and others) are trying to label the previous call-outs as “old and false”.**

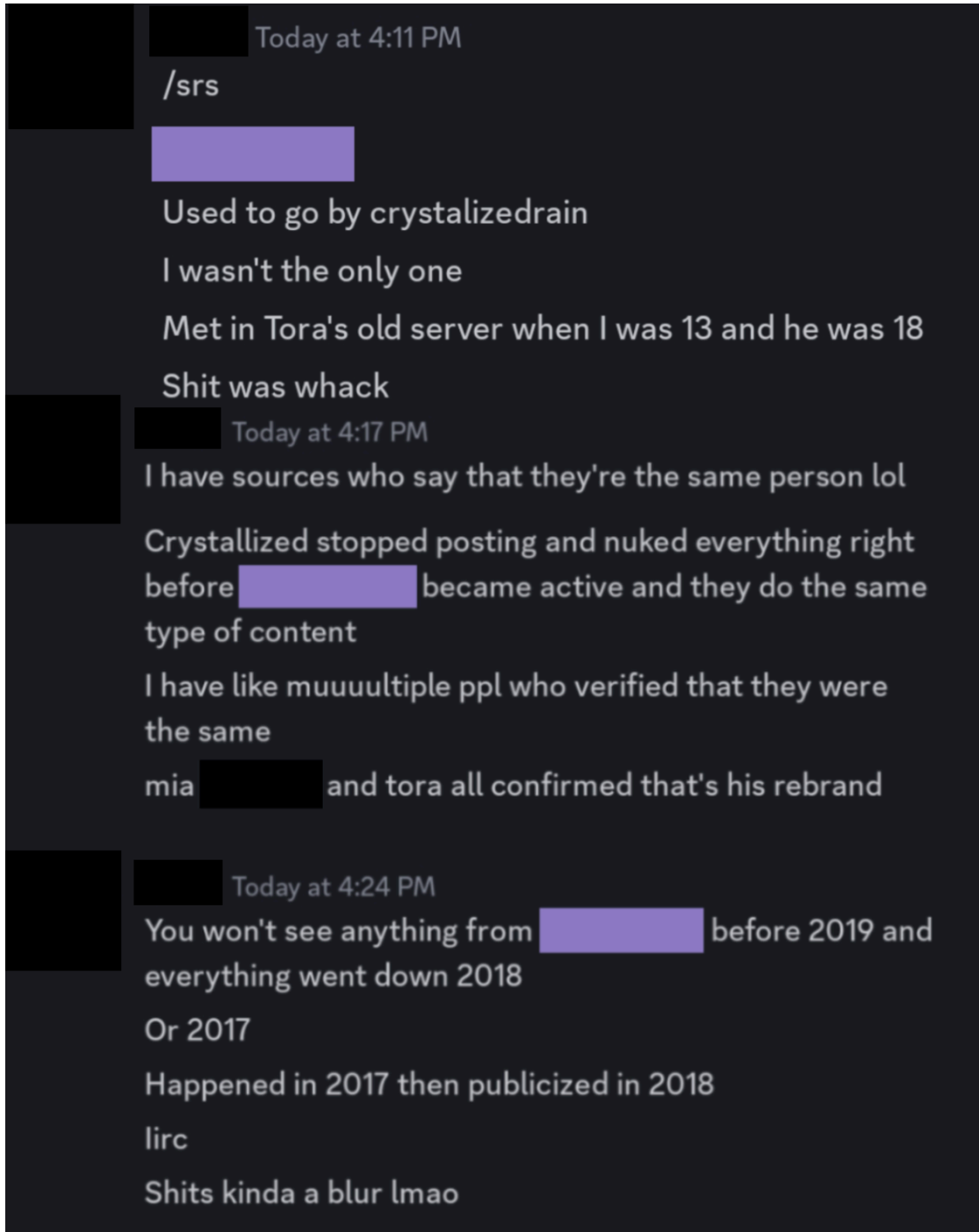

In August 2024, **another Vocal Synth user** has been spreading in a Discord server private chat an accusation of user [REDACTED] **supposedly being [CrystalizedRain/Joey](#) (a previously known [predator and groomer from the VOCALOID community](#))** with no visual evidence of them being the same person aside from saying verbally they saw the rebrand, mentioning four users as persons who “verified” and confirmed the connection; **two of them being [mia](#) and [TORA](#).**

**TORA is indeed in contact with big people**, *slandering* and *defamating* users in the community, just like they would do in previous years.

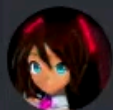

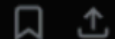

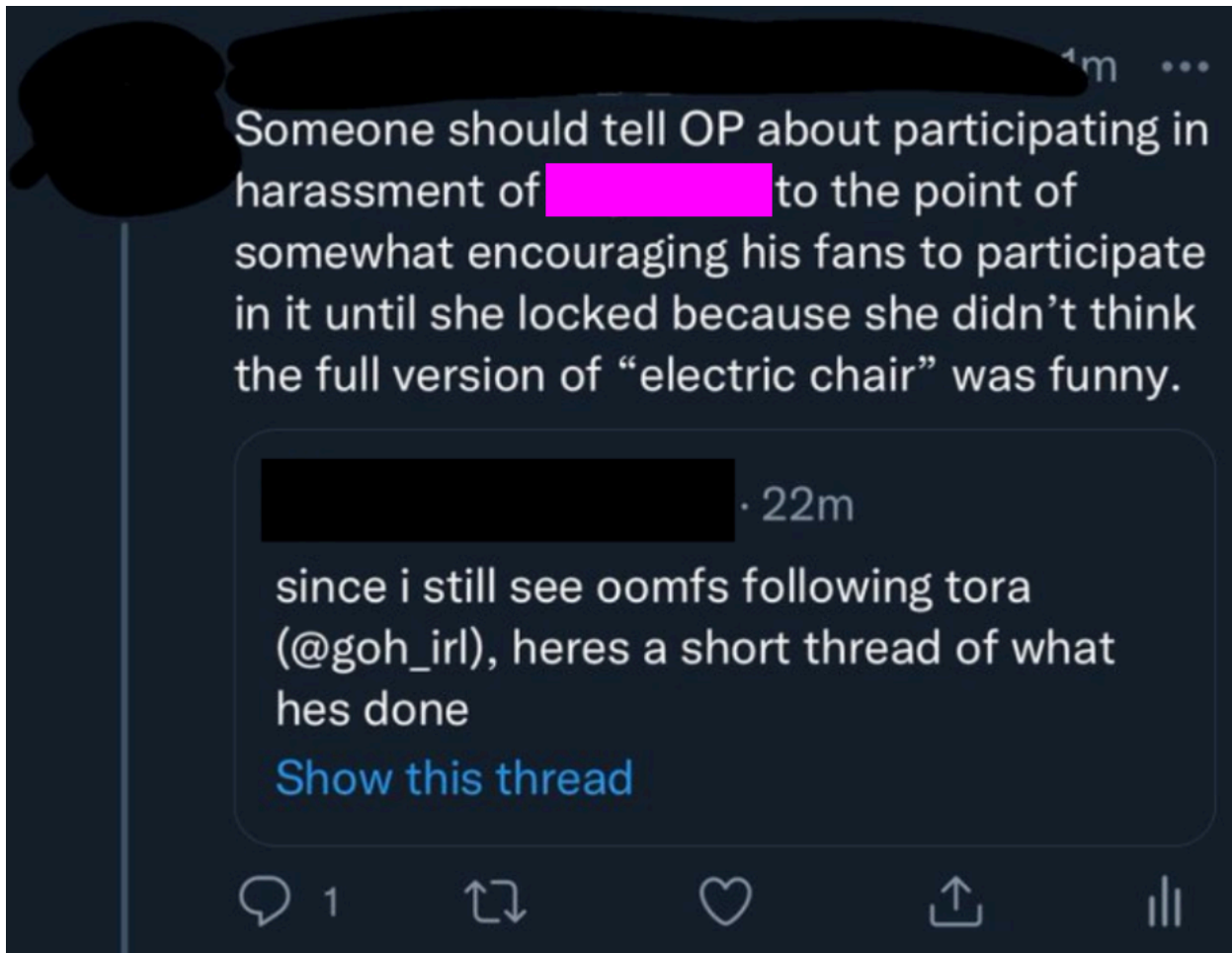

## Conclusion

**TORA is not only a toxic and manipulative gossiper, but also a predator, a groomer, a zoophile, a transphobe, a liar, and an incestuous and pedophilic shotacon. They're not only generally problematic, but their extremely rude and disgusting actions have done irreparable damage to the community.** TORA is someone who *for years* has taken advantage of their fanbase and contacts so that they and their friend group can **still** engage in bigoted toxic patterns of behavior, and should not be allowed into public spaces of the fandom.

To conclude this document, I would like to make it clear that **this is mainly done to inform everyone about TORA\_V4 and those associated with them.** Almost *all of this information was already public knowledge*, it's important to understand all the context and prevent future cases of people getting involved with TORA and causing greater harm to more victims. TORA is a person who will obviously continue with life and mature at their own pace; **however**, the fact that they remain in frequent contact with the VocalSynth community (including big artists) and continues to have harmful conducts **does not demonstrate that TORA has been able to grow up as a person over the years**, despite being an adult over 27 years old.

TORA *and anyone that associates with them*, especially those that actively *swept* their actions under the rug and enabled their behavior, are a **huge threat** for a space such as the Vocal Synth community where so many *vulnerable children/minors* actively engage in it (especially queer youth that are arguably in a lot more vulnerable position compared to other people their age). Adults in the community should be protecting younger people present in it, not engaging with people and actively enabling actions that put them at risk of being harassed, groomed, or otherwise exposed to toxic and sensitive topics.

People who have been shown to be part of their circle constantly claim that they have distanced themselves or are going to distance themselves from TORA; however, even days later, they reconnect with/refollow TORA as if nothing had happened. It is important to consider: **How trustworthy are these people in the community, after *lying* multiple times to their friends and followers that they had supposedly distanced themselves from someone as *harmful and extremely problematic* as TORA?**

Taking in mind previous responses from TORA, **it is highly possible they will dodge the call-out**, by once again writing a vague apology to delete later and changing identities after this document is submitted for public view. If anything, don't let them still get away with their actions: do not allow a *malicious user* to continue getting involved in the community.

*Furthermore, as seen on several occasions, this type of user prefers to divert people's attention toward the person who exposed them (whether by citing a link to a document against the person who exposed their actions in a post as a way to silence them, spreading rumors on third-party servers, etc.), in which case I would like to emphasize that, by doing this, it still fails to justify or account for the actions they have taken and will continue to take in the future.*

**GenoX's personal statement for TORA:**

- As someone who was yet another ex-fan of your content back in 2018-2020, I am truly disappointed in the damage you have done, not only to other people, but also to me as a kid whose intentions were never intended maliciously.

The amount of people who have attacked me back then, the many times I ended up crying uncontrollably behind my screen, how I was ALSO exposed to the shotacon content in your server while being a minor (in chats AND calls), all of you casually calling me racist or transphobic or even calling me a groomer at that age (which, at this point, it looked like projecting yourselves on me), the groups I got banned from because of your circle bullying me and labelling me as if I was an actual evil person—all of this feedback from you and your friends over immature conducts coming from an annoying 13yo who wasn't aware of what they were doing, still growing up and just getting in touch with an english community for their first time ever; haven't you ever CONSIDERED all of this was absolute cruelty?

It seems I expected too much when I thought that you, as an adult, could prevent someone much younger than you from participating and being exposed to questionable behavior, and that, instead, redirect your followers to a healthier space where they could learn appropriate behavior.

If you and your friend group insist that you have changed over the past 8 years multiple times, why is your group STILL deep-searching screenshots written by a minor, and sharing it around assuring a 19-year-old behaves the exact same as when being 13? Why insist you have changed with such time, and not anyone else who also had that time to grow up as persons while ACTUALLY showing improvements, unlike you? It's extremely contradictory, and the damage is still present after all these years, as I keep getting harassed by other people over those screenshots you and your circle has spread in the first place from when I was young. A damage done by you and your friends who were AWARE of what was being done with such actions.

I don't even know what to expect from you or any of your friends after this document is published, as the other times I would get silenced by someone related to you who would post an old document with screenshots from when I was just a kid; You guys have NEVER reached out to me or to any other victim ONCE for even attempting to solve stuff privately, and you CAN'T deny the many times I tried to be the first one to reach out to literally anyone from your group, even if I was getting harassed, and got ignored. It seems your circle only cares about doing damage instead of taking care of the consequences; There would even be times your little friends would interact with my posts and content even after insulting and being extremely rude to me previously, something that would make me extremely uncomfortable as it is a very two-faced conduct that would keep confusing me as time went by. During the past years, I've met and been aware of even more people who, just as me, were also victims of the cruel and hurtful actions from your group.

I'm not only writing this document to inform everyone about what you did and what I experienced within your group, but also to keep others safe from your harmful actions, as you have shown to not have good intentions at all nor be a reasonable human being after all these years, with no improvement whatsoever. I do not want more people to keep being harmed by you nor anyone from your group. I absolutely despise how disgusting you are, you piece of shit.
